

By signing this pledge, we commit to the following principles in our activities:

1. We pledge to constantly improve our organization's sustainable performance. We commit to obtaining a GSTC-accredited sustainability certificate (Global Sustainable Tourism Council), or any other certificate of sustainability in tourism recognized by the UN World Tourism Organization, which we will implement in two years.
2. We undertake to implement in activities of our organization the criteria of international personnel qualification standards specific to the activity we perform or participate in, such as IRF GTA (rafting) - International Rafting Federation Guide Training & Education, IFMGA (mountaineering, free ride skiing, canyoning) - International Federation of Mountain Guides Association, UIMLA (hiking) - Union of International Mountain Leader Associations, ICO Pro (International Canyoning Organisation for Professionals), APPI (paragliding) - Association of Paragliding Pilots and Instructors, IPPI (paragliding) - International Pilot Proficiency Identification, PADI (diving) - Professional Association of Diving Instructors...
3. We undertake that when performing or participating in the adventure activities, we will use exclusively safe equipment that meets the EN (European Norm) and CE (Conformite Europeenne) provided for the specific activity or the norms that are in line with the PPE - Personal Protective Equipment standards.
4. In our organization activities, we will use means of transport that follow the national regulations for the safe transport of passengers.
5. During the implementation of our activities, we will cooperate only with accommodation facilities that are registered following the national regulations and that have certificates for the safety of guests, staff, and food.
6. We will carry out our activities following the positive legal regulations that apply in the country where the activities are implemented.
7. During the implementation of our activities, we will adhere to the standards and good practices for health, safety, and risk management.
8. We foster positive relationships with local communities and stakeholders, supporting their social and economic development. Wherever possible, we collaborate with partners who are committed to reducing their environmental footprint.
9. We prioritize tourism development based on the quality of the visit, not the quantity of visitors, to improve the travel experience while preserving the character of the destination and benefiting local communities. We advocate for a balanced seasonal and regional distribution of tourist visits and respect for the carrying capacity of the space.
10. We encourage visitors to have a respectful and responsible attitude towards the natural and social environment.
11. We prioritize education and awareness-raising on sustainable tourism, inspiring responsible travel behaviors and practices among our stakeholders and communities.
12. We continuously monitor and evaluate the impacts and outcomes of our initiatives, seeking to improve our performance and practices in alignment with the best available knowledge and standards.

13. We pledge to collaborate closely, fostering linkages with companies and individuals across borders, sharing knowledge, resources, and best practices among fellow members, and supporting initiatives that promote regional integration of responsible tourism.
14. We are committed to creating an organizational culture that is inclusive, equitable, and respectful for all members. We advocate for fair treatment, equal opportunities, and professional development within our organization and in our partnerships with stakeholders and communities.
15. We promote fair and ethical practices. We ensure the integrity and quality of our initiatives while providing accurate and transparent information to our stakeholders.
16. We pledge to actively participate in the association's activities, including attending meetings, engaging in working groups, and contributing to the advancement of our shared goals and objectives.
