Take Action on Expanding Absentee Voting in Response to COVID-19

Background: With the continuing outbreak of COVID-19 in New York State, voting rights advocates are concerned over voting procedures for upcoming elections. The Governor has postponed the April primary and special elections until June 23rd, but experts are predicting that the outbreak of COVID-19 will still be active at that time. Although the League believes that in-person voting should continue to be an option, we are advocating for the expansion of absentee voting so that voters who are at high-risk of contracting COVID-19 can apply to vote by absentee.

The League is supporting <u>A.10203/S.8015</u>, an act to amend the election law, in relation to permitting absentee voting in the event of a public health risk.

Currently, New York's law only allows an individual to request an absentee ballot if they

- a) will be absent from their county of residence or New York City on the day of the election.
- b) are unable to appear at the polling place due to illness, physical disability, or care-taking responsibilities for someone who is ill or disabled,
- c) are a resident or patient at a veteran health administration hospital, or
- d) are currently being held in jail.

These restrictive criteria do not accommodate people who are concerned about the risk voting in-person would pose to their own or others' health. High-risk individuals who are trying to limit their potential exposure or others' exposure to the virus should not have to decide between protecting their health or exercising their civic duty. Similarly, individuals who are preventively quarantined should still be able to participate in our elections.

This bill would allow New Yorkers to request an absentee ballot if they are unable to appear personally at their polling place because of a public health concern that voting in person could expose themselves or others to that risk. This will ensure that all New Yorkers can feel comfortable participating in New York's upcoming primary election in June.

<u>How to Take Action:</u> Although the legislature is in session, many legislators' offices are operating with limited staff. Typically, we encourage members to take action by making phone calls but because of partial staffing, we are recommending members use email and social media

to contact legislators. Members can still try to call offices but it's highly likely you won't get through to their staff.

Sample Email/Call Script:

Dear Assembly Member/Senator XXX,

I write to urge you to support A.10203/S.8015 legislation to expand election law to allow absentee voting in the event of a public health risk in response to the ongoing outbreak of COVID-19.

Currently, New York's election law only allows an individual to request an absentee ballot based on a list of approved reasons including sickness, caring for a sick or disabled individual, or absence from your county or New York City. These excuses do not cover the current state of emergency related to COVID-19. This bill would expand the reasons for requesting an absentee ballot to include if they are unable to appear personally at their polling place due to a public health concern that voting in person could expose themselves or others to that risk.

No voter should have to choose between exercising their democratic right or protecting their health. Expanding absentee voting will keep voters and election officials safe from further spreading COVID-19 while allowing them to cast their ballot in the June elections.
