



CALL FOR ABSTRACT

The Committee is accepting abstracts to be presented in the 2025 Annual Scientific Meeting of Indonesian Sports Medicine Association which will be held at Prime Plaza Hotel, Sanur, Bali, October 30-31 and Nov 1, 2025. The abstract can be in the form of case report, literature / systematic review, or original study.

Submission detail

Abstract submission can be done by sending the abstract to our email: ilmiah.pit.pdsko@gmail.com.

Submission deadline

The deadline for abstract submission is on August 31, 2025, 11.59 PM (GMT+7 / Jakarta's time).

Acceptance Announcement

The abstracts will be reviewed by the reviewer team appointed by the Committee. The acceptance announcement will be done on September, 2025. This acceptance decision is the full authority of the committee.

Author & Co-authors

Every participant is allowed to:

- Submit 3 abstracts, i.e. 2 as the main author AND 1 as the co-author, OR
- Submit 2 abstracts as the main author, OR
- Submit 2 abstracts, i.e. 1 as the main author and 1 as the co-author, OR
- Submit 1 abstract as the main author, OR
- Submit 3 abstracts as the co-authors

Types of Presentation

- Poster
- Oral

The participant can choose the preferable type of presentation, but the final decision about the type of the presentation will be decided by the Committee.



Category

- Undergraduate (1st author must be bachelor/undergraduate student)
- Open (Medical Doctor, Specialist, Master, Doctor, Professor)

Format of the Abstract

The abstract should be written in English, with the maximum of 400 words, and haven't been presented in other scientific meeting.

The description of the format is as the followings:

1. The whole abstract should be written using Times New Roman font and single spacing.
2. Abstract title: size 14 pt font, in capital, bold, centered, maximum 16 words, and including the main keyword.
3. Author's names: size 12 pt font, not bold nor italic, the number that represent the affiliation code is written after the last letter of each name in superscript manner.
4. Author's affiliation: size 10 pt font, left aligned, 1 inch indentation from the left edge.
5. The body of the abstract consist of:
 - a. Background
 - b. Method and Results for Literature / Systematic review and original study, or Case Illustration for Case Report.
 - c. Conclusions
6. The body of the abstract is written with size 12 pt font, justified alignment, no bold or italic format (except for non-English words).
7. Keywords: can be a word or a phrase, 6 keywords maximum, size 10 pt font, in alphabetical order.

Publication

Abstracts will be published in the Proceedings Book of the Annual Scientific Meeting.

The Participant Registration

The presenters whose abstract is accepted, is obligated to register as the participant of the Scientific Meeting. Any of the authors are also welcomed to attend the Scientific Meeting. Presenter who is failing to confirm his/her presence at the Scientific Meeting at the appointed presentation schedule will be considered absence.

ABSTRACT TITLE

The name of the First Author¹, Second Author², Third Author³, etc

1. Affiliation of the First Author
2. Affiliation of the Second Author
3. Affiliation of the Third Author
4. etc

Background: includes an introduction about why this study / case is important and needs to be done / reported.

Method: includes brief details about the methodology used in the study.

Results: includes brief details of important findings from the study.

(If it's a Case Report, then there's no Method and Results sections. They will be replaced by the Case Illustration section)

Case illustration: includes brief details of what the patient(s) presented with, including the patient's age, sex and ethnic background.

Conclusions: A brief conclusion of what the reader should learn from the study / case report and what the clinical impact will be.

Keywords: This section consists of three to six keywords/phrases representing the main content of the article. It is written in alphabetical order (10-point font), the main keyword is written in a bold format, and gives commas between words/phrases.
