Another workshop I went to was about AI and how it is becoming more prevalent in all industries. I mentioned in this workshop how it definitely affected the airline industry. I asked "Does everyone remember the IT meltdown that happened 3 weeks ago that left crew stranded

for days in airports". I specifically mentioned Delta airlines and how they are not unionized. It was very interesting because a lot of airlines use computer systems for our scheduling systems as well so AI is very prevalent in our industry.

The next day, Keturah rocked her speech during the main session. All the flight attendants cheered for her and what she was saying. The session I went to with AFA was very informative because it taught us correct ways to communicate with our coworkers. It can be difficult for people to do so. I think the presenters did a great job at explaining exactly how to do so and making the workshop extremely interactive.

Overall, this conference for me has been a very informative and uplifting experience because it showed me the importance of just informing yourself of different issues. Also, being able to bring back things that I can absolutely implement in our local committee. It also helps that I have the support from my local leadership in Detroit to

implement things like having a QR code to use for information for flight attendants about voting. Lastly, meeting all the people I did like Cindy, Guy, and everyone else I made connections with. I will cherish this experience and use it to get to work here in Detroit.

This year's CWA Human Rights Conference saw the largest attendance in the conference's history, with over 500 registered attendees, including AFA members from carriers and bases across the country. We were there not only to learn from our union siblings from other industries, but also to meet with fellow AFA members who are passionate about human rights and build on our union solidarity. The AFA-CWA International Human Rights and Equity Committee has been working hard to develop a network of human rights activists at every AFA carrier who can share concerns and collaborate on education and resources to benefit the entire AFA membership. The ability to build relationships with AFA members from other carriers is key to our collective power as a union.

The AFA-CWA International Human Rights and Equity Committee presented a workshop at this year's conference titled "Sex and Gender Identity in the Workplace and in our Unions." The purpose of this interactive workshop was to explore the differences between sex, gender, gender identity, gender expression, and sexual orientation in the workplace and in our unions. We were able to provide a lexicon for discussion and dive into activities and conversations around perceptions of gender and how they show up in professional settings and beyond. Our goal was for attendees to walk away with knowledge and deeper understanding of these topics as well as the tools to have informed and appropriate discussions in the workplace and within our unions. We had over 100 attendees at our workshop and received overwhelmingly positive feedback. Many people shared personal stories with us after the workshop and thanked us for bringing this important topic to the CWA Human Rights Conference. We were able to educate our fellow CWA siblings and give them valuable resources that they can bring back to their unions so that they can better support their membership.

Our workshop was also an opportunity to get feedback to help us develop this into an online training for all AFA members to access in the future. The International AFA-CWA Human Rights and Equity Committee, along with our reporting officer, AFA-CWA International Vice-President, Keturah Johnson, will continue to develop trainings and resources for our membership in order to address inequity and human rights issues within our industry.

It all started with the opening ceremony to kick off the conference the first night. We had anthems from several countries that CWA has unions in, followed by amazing speakers to kick off the conference. There we also meet fellow AFA siblings from Frontier, Spirit, United, Endeavor, Piedmont, Hawaiian, and many more. We listened to encouraging words from several CWA District leaders, CWA Chairs, and the president of IUE-CWA.

DAY 2: We started off this day with speeches by many CWA leaders, as well as President Claude Cummings, And congressman Al green from TX-9th district. That momentum and chant for the week was "No vote, is a vote" There was encouragement to get the vote out, but to also vote! It wasn't so much as political, as much as it was a reminder of where we are in the labor movement. In the plenaries that day, I attended Beyond the Border and Voting Rights, Voter Suppression: What's at stake in 2024. Beyond the Border: This one was an interesting one, it mainly talked about how people go about getting work visas, but also how the systems hard from some, you have to reapply yearly, which makes it harder for immigrants to get a job due to this hurdle. And hope some of the Unionized farm workers rely heavily on their union, but some don't even get the benefits of the union. Even if they pay dues. Talked about getting protections for Visa workers in contracts. Voting Right, Voter Suppression: This was the one I wanted to attend the most, sadly I was not able to get the full experience, due to timing issues on the presenters part. It was cut in half to 45 min. They did talk about Project 2025, and was presented by the NAACP, we were mainly given a sit to go to for all the information for a pro labor, and pro voting form of NAACP's "our 2025"

DAY 3: This day was AMAZING! Keturah spoke during the morning session about Voting, Labor, airline industry and about her history. We also heard from many other CWA guests as well. The plenaries that day were great to choose from, although one had been canceled, so I stayed for both the ones that AFA headed up. Sex & Gender identity in the workplace and unions: This was an amazing education session in the beginning about where we are at in this time of sex and gender identity. We talked about non-binary, trans and the differences with that, outdated words, and also how to have protections in contracts, such as changing He/Her of He/She to They/Them and Their, so that contacts are more gender inclusive. It was also mentioned how we can use these practices to help educate our work group to follow these guidelines. It was brought up that when people resist using correct pronouns on purpose, that they can be terminated due to harassment. We did a part where we asked people to profile people, so that it could help educate them better. This was my favorite seminar, and most educational in my opinion.

DAY 4: We got to listen to Colin Allred talk about how impotent it is for us to have a pro labor government, so that we can get legal protections that we don't have to continually fight for, and talked about voter suppression. We had the Activist mall that was very educational as well. Here I got to meet IWA, (international women's association) And learn about the fight that they are doing in other countries to try and help other working class people unionize and stand in solidarity. What they were working on at the time was Starbucks united, and Philippines, where in the Philippines, people can be imprisoned for trying to start a union.

All in all, this was a well worth it conference. I learned so much, was able to interact with other Labor unions, and fight for equality. Words can't fully explain how much I loved this conference, and how much it refueled me for the fight this year, from contracts, to basic worker rights. This is a conference that is worth the cost, and would be worth having a large crowd attend. The next one is in 2 years, and I hope to be able to attend again!

The "Voting Rights and Voter Suppression What's at Stake in 2024. Was cut short and mainly gave us a link by the NAACP where we can find more information about 2025. And how this will affect voting rights and voter suppression.

The "Sex And Gender Identity In The Workplace And In Our Union Workshop". Gave us an insight on sex and gender identity and how one can mistakenly be identified. The participants who came to this workshop had the opportunity to interact with each over sensitive subjects of sex and gender identity in the workplace. During this workshop we had the opportunity to play an interactive game called the privilege game where we had X amount of dollars to choose which privilege we felt was important to us. We will come to find that no matter what your sexual identity may be we are all human and can come to believe we all feel the same. One more interactive opportunity we had was to guess the sexual identity of different individuals that were shown to us and what we perceived that person to be. My experience in the CWA Human Rights Conference has been an amazing eye opener. Not only did we create visibility and represented the minorities in the aviation industry, but we also got to meet and network with a lot of amazing people from different walks of life that have their own struggles and sense of purpose. Our own struggle can sometimes create this deep seething focus, turning a blind to the struggle of others. This event has been an eye-opener and has given me a new sense of perspective. I learned about abortion and how most union contracts have no abortion protection or clauses, which has been more relevant now that Roe Vs. Wade has been overturned. The only contracts under the CWA umbrella that have some sort of abortion language is CLEW and the news guild. Many states have banned abortion which has caused financial, emotional and physical suffering to women in the workforce. We, as flight attendants, are in a better position as we can travel between states for free or discounted... whilst others must rely on their own time and money to make abortion arrangements. I took some notes (attached) and listed resources to help those women in the aviation industry. I am hoping to bring this up more in our future meetings to further navigate,

advance, and establish protections and clauses to help those aviation women in need. Speaking briefly with Keturah, I was made aware that we have something called ELEVATE. I would like to inquire more about this during one of our HRC meetings!

I also learned the effects of AI in labor. Technology and automation should help labor, not replace the workforce. Thankfully, the threat of automation in flight attendants are very low, but it is still good to be aware of how the future of technology can affect our work environment.

In addition, one of the speakers represent a law firm that protects on the job injuries for CWA members... it made me realize that not all on-the-job injuries are sudden and some can creep into us without us noticing it until it's too late. Ex. Chemical (ie: Asbestos) poisioning and degradation in our physiology through repetitive strain while on the job). As flight attendants, we are constantly exposed to infectious diseases, radiation, extreme noises, and air quality poisoning. It made me realize, how are we protecting our AFA members? I would like to bring this up in our next meeting also. I attached the law firm's business card who spoke at the last day of THE CWA conference. I hope we can work with him in bringing attention to the dangers of flying and how we can protect ourselves as flight attendants.

In conclusion, although our various struggles can cause discrimination, unfairness, and sometimes even violence... through these events we find a sense of unity and solidarity that turn those struggles into a weapon of solidarity. Through this unity, we can learn from one another and empower each other in fighting for equality and fairness in our prospective line of work. These conferences are very important and I will continue to push our involvement in these events which is effective in our goals as human rights chairs of AFA.
