1. INTRODUCTION

This app does not analyze or collect any private or image related data on your device, nor does the app send any of this data to webservers.

To fully experience our services, please also note that you should enable us to access to Photo Album permissions in your phone. Then, you can create stunning GIFS and save your edited GIFs. You can also disable such access permission in settings of your phone if you do not think it's necessary.
