**Project Participation Agreement**

**(Funding Participation Agreement)**

Thank you for your interest in participating in the moja global Project (“moja global”). This participation agreement is required to be executed by organizations that are committing funds to moja global. Organizations that do not wish to commit funds to moja global but that wish to participate in the governance of moja global by having representation on either the Management Board or the Strategy Board should contact [info@moja.global](mailto:info@moja.global) to request a non-funding participation agreement. Technical participation in the project is open to all, provided, that technical participants must comply by the terms of the moja global Charter (attached hereto as Exhibit B, the “Charter”).

Participants agree to comply with the terms described in the moja global Charter and with all such applicable policies as moja global and/or the LF Board of Directors may from time to time adopt with notice to participants; provided, however, that The Linux Foundation shall provide at least sixty (60) days notice of any new or revised policy during which time any participant may, prior to the effectiveness with respect to such participant of such new or revised policy, withdraw from moja global by delivery of written notice to The Linux Foundation.

Note that this is not an indication of interest; execution of this agreement creates a binding obligation for the participating organization to make the payments provided for and to otherwise perform in accordance with its terms. Any payments are non-refundable.

Please note, if your organization is a for-profit organization, membership in LF is required. The term of participation in the moja global Project pursuant to the terms of this Agreement shall renew for successive one-year terms on January 1 of each year, unless you have provided written notice to the moja global Project prior to December 1 of the prior calendar year of your intent not to renew participation.
