1. Instructions of main text writing

(Single, 12 pt after)

The manuscript is written in the format of 1 columns, 12 pt Times New Roman and Letter paper size, single- spaced, justified alignment, margin of 3 cm (left, right, top, bottom). The distance between paragraphs is 12 pt after. Manuscripts including graphs and tables should not exceed nine pages. Title of the article should be brief and informative and should not exceed 20 words. The first letter of the Title and Subtitle of the chapter is written with capital letter and is not numbered, the distance between title or subtitle is 12 pt after.

The manuscript of the journal should include **Introduction, Methods, Results, Conclusion, and References (Bibliography).**

Abbreviation / Term / Symbol. The use of abbreviations is allowed, however such abbreviations should be fully given on first mention. Foreign term should be written in italics. Symbols are also stated clearly and distinguishable.

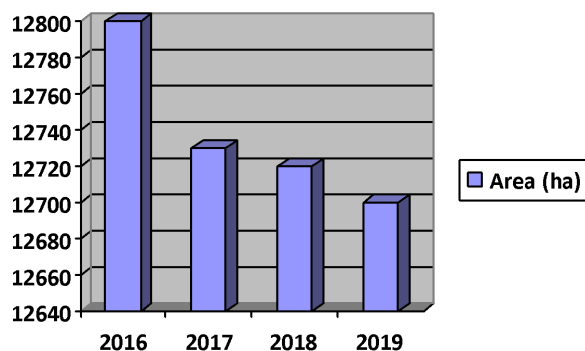
