### *Institutional Updates:*

- Martha from Berkshire
  - Inundated with students! New rural health program of some sort, likely associated with some Boston medical program. The center is also expanding their substance abuse treatment programs. Martha reported having problems with theft, especially of her psychology collection.
- Sarah from AIC
  - Working with MSN program! Some discussion on embedded librarianship (see Anna's report from MLS)..
- Bridget from Baystate
  - Baystate will affiliate with UMass Med in 2017, ending its affiliation with Tufts. The library is planning support for new, larger student programs. Currently, Baystate doesn't do a lot of library instruction in a classroom setting. New classrooms are being built in 3601 Main St building that currently is largely animal labs.

  - Margot had a flat tire this morning, whew. Margot works with patients and families, took responsibility for the Consumer Health Library at 3300 Main St about 5 years ago. Due to staff shortages, CHL reduced its hours from Mon-Fri 9-5 to noon-5. Margot does a lot of outreach, which results in more email/phone questions, but walk-ins are still low. The plan is to open CHL on Mon and Wed mornings to boost walk-in reference questions. The medical interpreters make heavy use of the consumer health library, too, and sometimes bring in patients.
