- Ensuring action plans and projects makes good use of resources.
- Assisting with resolving strategic level issues and risks.
- Approving or rejecting changes to priorities or projects.
- Assessing progress against objectives and targets and reporting on these to the Trust Board
- Providing advice and guidance on operational issues facing the action plans / projects.
- Using influence and authority to assist the action plans / project in achieving its outcomes.
- Reviewing and evaluation of the progress of action plans and strategy
- Reporting to the Trust Board



ALIGNMENT

Our approach aligns with DfE recommendations:

- Decarbonisation, for example calculating and taking actions to reduce carbon emissions, such as becoming more energy efficient
- Adaptation and resilience, such as taking actions to reduce the risk of flooding and overheating
- Biodiversity, for example engaging with the National Education Nature Park
