What is the intended use of the "Protecting Our Students" Videos Canvas Courses and this landing page?	Welcome to the course guide for the North Carolina Education Modules under the Protecting Our Students Act (Session Law 2023-128/HB142) and in G.S. 115C-105.57(2a). The Protecting Our Students course guide and videos were developed as required by general statute and session law. This information was developed by the North Carolina Center for Safer Schools in partnership with Capitol Broadcasting Company, the purpose of which is to provide K-12 school employees with important information about inappropriate behavior and adult sexual misconduct in school settings. We are sharing these materials with you in part because of G.S. 115C-105.57(2a) and Session Law 2023-128/HB142. This Session Law required the videos to be developed and to be shown to students in grades six through 12 and the videos should be delivered to all public school units. This course material is provided to you with what is necessary to comply with this legislation. A staff video has also been made for sharing with staff prior to the Grades 6-12 videos (middle and high school videos). The staff video is strongly suggested to be shown to staff prior to the school staff facilitating the course and videos with middle and high school students. The purpose of the Canvas LMS Course Training Package that has been developed is to assist North Carolina Public School Units (PSUs) in providing Protecting our Students Videos to staff and students as required in <a href="Session Law 2023-128/HB142">Session Law 2023-128/HB142</a>.

This is a **no-cost** training package that PSUs may utilize to ensure that they understand how to access the videos in the Canvas System. It will also serve as a resource to provide the videos and information for PSU's that do not have CANVAS or have staff who do not have accounts in CANVAS.

PSU's should use the CANVAS for the staff that already have an account in CANVAS. If an account does not exist in CANVAS- the PSU may use this information and upload it in their own management system or utilize this in Google Classroom.

Please note that the content should not be altered in order to preserve the integrity of the training and to meet legislative requirements. Every PSU will need to ensure that they read this course description and understand <u>course requirements</u>.

# Why are the "Protecting Our Students Videos Important?

Watching prevention videos about inappropriate behavior and abuse can be challenging for many people due to the emotional weight of the subject. The distressing content often evokes feelings of sadness, anger, and fear, making it uncomfortable to confront. Additionally, cognitive dissonance can arise as viewers struggle to reconcile the harsh reality of abuse with their own perceptions of safety. For those with personal connections to the issue, the pain can feel even more acute.

Many individuals also experience a sense of helplessness after viewing such content, fearing they won't know how to take action. Societal stigma surrounding discussions of abuse can further discourage open dialogue, leading to feelings of shame or discomfort. However, the "Protecting Our Student" Videos help school staff and students understand and learn how to report inappropriate acts and behaviors against students.

Despite these challenges, engaging with prevention videos is crucial. Understanding the realities of child abuse is the first step toward creating awareness, fostering dialogue, and

	Pushing through the discomfort to talk about and understand prevention around child abuse is essential for several reasons:	
	<ol> <li>Raising Awareness: Open discussions help inform people about the signs of abuse, enabling them to recognize and respond effectively.</li> <li>Empowerment: Knowledge equips individuals with the tools to take action, whether that means intervening, supporting victims, or advocating for policy changes.</li> <li>Breaking the Silence: Talking about child abuse helps to dismantle the stigma and secrecy surrounding it, making it easier for victims to come forward and seek help.</li> <li>Building Supportive Communities: Open dialogue fosters a culture of safety and vigilance, where communities are more likely to support one another and look out for vulnerable individuals.</li> <li>Prevention: Understanding the factors that contribute to abuse allows us to create and implement effective prevention strategies, protecting children before harm occurs.</li> <li>By addressing this difficult topic head-on, we can create a safer environment for children and promote healing and support for those affected by abuse. It's a vital step in making a meaningful difference in our communities.</li> </ol>	
What does Session Law 2023-128/HB 142 help schools do?	Clear communication is essential for effective prevention. Together, we can create a strong support network that empowers and protects our children.  Experience has shown us that proactive actions by adults are far more effective than relying on children to protect themselves from sexual abuse. It is equally important for children to receive accurate, age-appropriate information about sexual abuse, along with the assurance that trusted adults will support and protect them. It is also equally important that adults understand what inappropriate behaviors to report to ensure a safe environment for all students. <u>Session Law 2023-128/House Bill 142</u> (HB 142) in North Carolina focuses on providing additional protections for children and improving reporting mechanisms for child abuse and neglect. Here are some key aspects of what the bill aims to accomplish:

- 1. **Enhanced Reporting Requirements**: It establishes clearer guidelines for mandated reporters, ensuring that professionals who work with children understand their responsibilities to report suspected abuse or neglect.
- 2. **Training and Education**: The bill emphasizes the need for training programs to help educators, healthcare providers, and other stakeholders recognize signs of abuse and know how to respond appropriately.
- 3. **Support Services**: It aims to improve access to support services for children and families, promoting resources that can prevent abuse and aid in recovery for victims.
- 4. **Collaboration**: Session Law 2023-128/HB 142 encourages collaboration among state agencies, community organizations, and law enforcement to create a more coordinated response to child abuse cases.


By strengthening these areas, <u>Session Law 2023-128/HB 142</u> seeks to better protect children in North Carolina and ensure that those who may be vulnerable receive the support and intervention they need.

#### **OVERVIEW**

What is the general overview of the content of the "Protecting Our Students" Videos Canvas Courses?

Currently, this training package includes training for middle school students, high school students, and adults/staff who work in school buildings. The staff course is also designed for school staff to view the videos and information **prior to** sharing with students. The middle and high school courses are designed for school staff to use (after viewing the staff video) to facilitate and lead discussion with students in accordance with Session Law 2023-128/HB 142. PSU's are provided facilitator guides linked below in the adult and grade specific sections. The facilitator guide must be used while providing the videos.

Preparation for School Staff When Showing the Middle/HS VIdeos for the Course and "Protecting Our Students" Videos:

- 1. All facilitators for Middle and High School videos modules are strongly suggested to complete the Adult Video and Quiz first. Upon completion, please revisit these instructions.
- 2. Review the facilitator guide and videos before showing videos to students.
- 3. Use the facilitator guide to introduce and share the overview and introduce the videos to students. The guide also has processing questions with guidance for the facilitator. It is important to utilize the guide to ensure fidelity of sharing information in accordance with <a href="Session Law 2023-128/HB142">Session Law 2023-128/HB142</a>.
- 4. Ensure that the number for your local social services located at the end of this guide is shared with students. (This number is on the facilitator guide for your county)
- 5. Make sure to share the Say Something Anonymous Reporting information with students. It is located in the facilitator guide.
- 6. Help students understand where to report inappropriate behavior using the resources noted above.
- 7. Thank you for your support of students and for sharing this important information as mandated by <u>Session Law 2023-128/HB142</u>.

## Middle School -Staff Show this Information to students

#### Protecting Our Students-Middle School Video and Course

In this lesson, students will watch a short film produced in the style of a video-blog and covering the topic of inappropriate behavior by an adult. It features an onscreen host communicating directly with the audience and is accompanied by on-screen graphics. After students watch the film, discussion questions will be presented so that students can discuss and reflect upon what they have just watched. Because the topic of this film contains sensitive material, it is recommended that at least two adults are present in the classroom during the lesson (one adult to facilitate the showing of the film and to prompt and lead the discussion following the film, and one to monitor students in the room for signs of discomfort or distress). When possible, at least one of these adults should be a qualified mental health professional trained in educating students on topics related to personal safety and wellness, trauma informed principles and practices, responding to student disclosures, and recognizing signs of distress.

After watching the video, students will be able to:

HIgh School -Staff Show this Information to students

Protecting Our Students-High School Video and Course In this lesson, students will watch a short film featuring actors portraying students who have experienced inappropriate behavior by an adult in an interview-style setting. Three scenarios are shown, featuring stylized scenes and additional footage that recreates moments from the stories told by the main characters. After the film, you will present discussion questions to the class so that students can discuss and reflect upon what they have just watched. Because the topic of this film contains sensitive material, it is recommended that at least two adults are present in the classroom during the lesson (one adult to facilitate the showing of the film and to prompt and lead the class discussion, and one to monitor students in the room for signs of discomfort, distress, or other emotional triggers). When possible, at least one of these adults should be a qualified mental health professional trained in educating students on topics related to personal safety and wellness, trauma-informed principles and practices, responding to student disclosures, and recognizing signs of distress.

After watching the video, students will be able to:

- Understand what inappropriate behavior by an adult is and what it might look like if it is happening to them or someone they know
- Know how to practice healthy behaviors and skills to stay safe
- Identify a responsible adult who they could ask for help

This program is provided at no cost to PSUs and is provided by the Center or Safer Schools in partnership with Sandy Hook Promise.

Reporting Information:

• All tips are monitored by a crisis center that is staffed 24/7/365.

 Tips are compiled and classified into either lifesaving or non-life saving tips. Life Saving tips are sent to law enforcement emergency centers for possible intervention by law enforcement, as well as school counselors, school administrators and school resource officers. Non-life saving tips are sent to each school team and can be handled by counselors and administrative staff.

#### Tips for Delivering the Information and Student Disclosures

Possible Triggering Information: This lesson could provide an emotional trigger for some students. You and/or your teaching partner should actively look for signs of distress among students (e.g., crying, signs of agitation, nervousness, heavy breathing, putting their head down, attempting to leave the classroom, etc.) during the showing of the film and during discussions. Work with your school's mental health support and leadership teams to develop a plan for supporting students who become emotionally triggered during this lesson. For instance, it is important that you and your school have established a pre-arranged place where students can go to if they feel distressed and need to step out or take a break from the lesson. Use your judgment about whether you need to follow up with the student later and refer them to additional supportive resources.

<u>Student Disclosures:</u> Even though you will have encouraged students to keep discussions focused on the film's characters and scenarios, it is possible that the content in this film will lead to a student disclosing information about a safety concern from their personal lives. Use your judgment about how to handle this situation. If you feel the student is disclosing something especially private, or something that is more appropriate to discuss in a one-on-one context, you can proactively interrupt the student by saying something like "Thank you, it sounds like what you have to say is really important and I do want to hear it. Why don't we talk about it after class/at lunch/etc." and then carefully redirect the discussion back to the film. In some cases, it might be possible that a student approaches you to make a disclosure one-on-one after the lesson. Some tips for handling a student disclosure include:

- Give the student your full attention, and allow them to control how much they wish to disclose
- Acknowledge that you understand the student's feelings and let them know that the way they are feeling is understandable given their experiences
- Let the student know that there are mental health staff and other trusted adults at the school they can talk to and many resources and services available to them for getting help
- If you feel as if you need to involve other adults at the school, such as administrators or mental health support staff, let the student know your plans to do so
- Seek consultation from your school's mental health staff to ensure a plan is developed for supporting the student
- Avoid showing judgment, challenging details about the student's story, or pushing too hard for additional information
- Ensure that the proper reports are made to support the student and to secure their safety.

Public School Units (PSUs) are strongly suggested to submit this attestation form to the NC CFSS confirming that all school staff—both classified and certified—along with any adult engaging with students during campus or school-related activities, have viewed the mandated "Protecting Our Students" videos in accordance with Session Law 2023-128/HB 142.
