Course description

The course aims to study the key issues of European integration in the post-bipolar period, its legal framework, the formation and operation of European Union institutions, the mechanism of the common internal market, economic and monetary union, EU common policy, as well as the role and place of Ukraine in the European integration process.

The course is one of the electives for the master's degree major "Secondary education. History". The teaching of the course is based on the content of the whole cycle of professionally oriented disciplines of the academic program curriculum, which it logically complements and develops.

The purpose of learning

The purpose of the course is scientific knowledge of present practice of European integration as a unique phenomenon in modern world politics and economy; formation of students' European in nature and democratic in essence value orientations: humanism, personal freedom, respect for human rights, legal awareness, tolerance.

As a result of the course study students will be able to demonstrate:

Knowledge and understanding:

- factual material and modern scientific terminology on the problems of European integration;
- basic factors that determine the processes of European policy;
- historiography of controversial problems of European integration;
 - Application of knowledge and understanding:
- ability to use the acquired knowledge to analyze current events in the field of international relations;
- ability to search for scientific information in the relevant field of knowledge using search services and scientific social networks on the Internet;
- ability to carry out source analysis of international agreements and other documents;
- ability to communicate and carry out effective educational activities in small and large student groups; to lead discussions, clearly formulating and arguing their own position;

Attitudes

- assess and effectively implement their own learning needs and prospects for professional development and growth;
- modify and create new research and development projects using information and communication technologies;
- be tolerant, respect the freedom and values of others;
- to demonstrate the ability to make decisions in non-standard conditions, which requires the use of new

- approaches and forecasting, creative thinking;
- be aware of the need for lifelong learning, study, analysis, generalization and dissemination of best practices in the field, systematic improvement of their professional skills.

Forms and methods of teaching

The course will be presented in the form of lectures (24 hours) and seminars (16 hours), organization of independent work of students in libraries and computer networks (80 hours). The teacher will use problem-based and interactive teaching methods, consultations.

Course policy

- Attendance and / or participation is an important component of the course for students who have chosen it. Assessment for student work in seminars (group work, participation in discussions, individual tests) is a crucial component of the final score for the course.
- **Delay**. Being late for classes is undesirable because it disrupts the rhythm of the group and reduces the effectiveness of educational activities. Untimely (after December 1) submission of the essay excludes its assessment and enrollment in the final score of the course.
