Privacy Policy

We at shobot.io don't take your privacy lightly. We care about your privacy and have adopted comprehensive measures to take care of the information you have given us. Our practices have been described below in this Privacy Policy.

Our Privacy Policy can be summarized in the following words:

We use the information you provide to us only for the purpose to process your information returns. We do not and never will sell or share your information with anyone unless required by law, even if you no longer use our services.

Our detailed Privacy Policy is listed below:

Collection and Use of Your Personal Information

We only collect information that is necessary to serve you. We do not knowingly solicit or receive any information from minors.

We use the tax return information that you have provided only to provide the tax return services that you have requested. Except as described herein, we neither disclose tax return information to third parties nor use it to market third parties' products and services. For our records, we may, in our sole discretion, retain original and updated information for reasons such as technical constraints, dispute resolution, troubleshooting, and agreement enforcement.

We collect information from our users at several different points, including, but not limited to, the following:

Information You Provide to Us

Before you can use the services on the site, we ask that you sign up for a free account with us and provide us with your personal information, including your name, email address, and password. We store this information so that you can access our site securely and set up a password.

Correspondence

We retain any information that you provide during any correspondence with us.

URL and IP address

We collect information about our users' utilization and navigation of our site. This information helps us to design our site to better suit our users' needs. We also use your IP address to help diagnose problems with our server, administer our site, gather broad demographic information, and help identify you.

Cookies

Like many websites, we use cookies on our site. We only use cookies for the smooth operation of the web application.

Surveys & Contests

From time-to-time, our site may request information from you via surveys or contests. Participation in these surveys or contests is completely voluntary, and you may choose whether or not to disclose this information. Information requested may include, but is not limited to, contact information (such as name and shipping address) and demographic information (such as zip code and age).

Information from Other Sources

We may receive data from your Zoom account through our integration on Zoom's marketplace. We never share your information from Zoom, including meeting recordings, meeting transcripts, and meeting attendees with individuals or shobot.io users to whom you have not granted permission to view this data.

We may receive information about you from other sources, such as our agents, vendors, service provider, and publicly available sources. For example, we sometimes receive updated address information from third parties, which we may use to update our records.

Restrictions on Disclosing Information to Third Parties

We are not in the business of selling or renting your personally identifiable information to others.

We do not reveal personally identifiable information about you to third parties for their independent use unless:

(1) the information is provided to complete a transaction for you.

- (2) the information is provided to comply with the law, enforce our User Agreement or other agreements we have with you, or to protect our rights, property, or safety, or the rights, property, or safety of others.
- (3) the information is provided to our agents, vendors, or service providers who perform functions on our behalf.

Security Measures to Protect Information

To help protect the privacy of data you transmit through the use of this site, we use industry-standard security policies and procedures to help prevent unauthorized access to confidential information about you. Also, we train our employees about the importance of confidentiality and maintaining your information's security. We commit to taking appropriate disciplinary measures to enforce our employee's privacy responsibilities.
