

## DATA AVAILABILITY STATEMENT

Journal the Winners research data policy encourage or require the provision of data availability statements. Some research funders require data availability statements to be included in publications and Journal the Winners research data policies support compliance with these requirements. Publicly available datasets referred to in data availability statements can also be cited in reference lists – and this is particularly encouraged when datasets have digital object identifiers (DOIs). Data availability statements commonly take one of the following forms:
