02 - Behavioural Expectations

02.01 - RIS Student Code of Conduct	All RIS students should exemplify the qualities of the RIS Student Code of Conduct.
02.02 - RIS Student Uniforms	Students are expected to come to school with proper uniform and appearance every day. This document describes those expectations.
02.03 - RIS Student Use of School Site	Students should use the school site appropriately and access only permitted areas of campus, as defined here.
02.04 - MHS Student Device Policy	Students should use technology in a way appropriate for learning. This policy describes expectations for use of computers, phones, and other devices.
02.05 - RIS Student Food and Bar Use	Students should follow appropriate procedures for accessing food and the on-site RIS Cafe as outlined here.
02.06 - ES Discipline Framework	Issues requiring a disciplinary response in the Elementary School will follow this framework.
02.07 - MHS Discipline Framework	Issues requiring a disciplinary response in the Middle and High School will follow this framework.
02.08 - Discipline Investigation Process	Serious discipline cases will be treated in a more formal manner following these guidelines.

04.01 - ES School Day	The day in Early Years and Elementary School follows this schedule.
04.02 - MHS School Day	The day in Middle and High School follows this schedule.
04.03 - Class Placement Policy	In an international school setting, it is customary for students to experience changes and remixing within their year groups, contributing to a well-rounded educational experience.
