| Introduction and School Overview: | Mount Energy Elementary School serves 456 kindergarten through fifth grade students with a Character Education program that provides students with the tools needed to exhibit good character in school and in the community. Character education is embedded daily by our staff and counselors. We are a diverse Title 1 School with a high percentage of economically disadvantaged students (58%). Our current school demographics are 40% W, 30% B, 23% H, and 7% M. Our goals are to continue to increase student growth and proficiency, improve literacy proficiency, and increase parent engagement attendance. |
