A Month of No Catch

Venture Global says its LNG is low-cost. The truth is: **they are costing the commercial shrimping fleet in Cameron, Louisiana, their entire season.**

In August 2025, a dredging operation near Venture Global's Calcasieu Pass LNG terminal went awry. Instead of staying contained, tons of dredged river sludge spilled into sensitive bayous and Big Lake—smothering oyster reefs, trapping shrimp, crabs, and fish, and potentially contaminating seafood with unknown toxins. Fishermen's nets are caked with mud, and they do not know if the muddy seafood they catch are toxic.

The Port of Cameron, the local and state government, and Venture Global refused to believe the dredge spoils made it to Big Lake. Finally, on Sep. 3, the Louisiana Department of Fish and Wildlife confirmed silt is in Big Lake and is affecting the oyster population.

These bayous and fisheries are not just ecosystems. They are livelihoods. Generations of shrimpers, crabbers, and oystermen are watching their future disappear while everyone in a position of power allows LNG companies like Venture Global rake in billions and leave behind dead zones.

A recent dredging operation near Venture Global's CP2 LNG terminal in southwest Louisiana has unleashed a disaster.

Instead of storing dredged sludge, tons of river mud and debris are poured into Big Lake and nearby bayous, burying vital fish habitats and smothering oyster reefs. Shrimp, fish, crabs, and oysters are being choked out — and now, local fishermen's nets are filled with muck instead of seafood.

No one even tested the dredged material for toxins beforehand — despite state and federal regulations.

"I don't know if I'm even safe to eat my own catch," said one fisherman. "We've been ignored over and over."

This isn't just an accident — it's the latest blow in a long campaign of destruction that LNG companies like Venture Global are waging against coastal communities. And no one is being held accountable.

Enough is enough. We are demanding that Federal agencies stop the construction of CP2, and that European and Japanese financiers and buyers cut ties with CP2 and the U.S. LNG industry.
