## Agenda/Discussion

- School Infrastructure Questionnaire soft launch updates and initial feedback:
  - We've heard back from:
    - Arlington
    - Lexington - still in the works, Amber will follow up.
    - Newton - still in the works (Amber S. and Shara are working on this).

Main piece of feedback: Send questionnaire to superintendents directly.

- Reach out to DESE to connect to superintendents?
  - Amber Keller has a contact connected to DESE.

Specific feedback from Rachel at Arlington:

1. It would be helpful to have a place to add notes in more places than just at the end. I had notes to add related to the "cafeteria foodware," "waste sorting monitor," "cafeteria share tables," and "amount of food waste diverted" sections.
  - Leah will add a note in questionnaire instructions that encourages respondents to add comments to any drop-down or box where additional information is helpful or needed. Just right click and select "add comment."
2. I wasn't sure if I should create a "utensils only" section under "washed items" . I checked off the "cups/utensils" option even though we do not have reusable cups, just utensils.
  - Separate washed items into specifics: cups, utensils, etc (?)
3. I wasn't sure if reusable condiment pumps counted for the "reusables" in the drop down in the "cafeteria foodware" column or if that's intended to track just reusable trays, utensils, and cups.
  - No, not considered reusables. Leah will clarify in the explanation/definition doc.
4. For the "amount of food waste diverted" column, it might be helpful to specify how you want the data reported (in pounds or tons and for the school year vs. per week, etc) so we can compare data across districts more easily.
  - Lbs per week (we can convert it to tons as needed).
    - Wendy: per week helps motivate school community.
  - Municipalities can note compost tonnage in their MassDEP Solid Waste Survey (at the end).
  - RecyclingWorks TA records quantity in tons.

Claudine will check with the Green Team on the status of converting the questionnaire to a teacher response form.

  - HB529 Sponsored by Rep Ciccolo
    - CHAPTER 111, SECTION 223 of the General Laws is hereby amended by inserting after SUBSECTION (g), the following- "(h) The Massachusetts School Building Authority shall promulgate regulations requiring applicants for funding for construction of new schools or

substantial renovations of school kitchens (1) to install dishwashers which will allow for the use of reusable foodware, (2) to adopt procedures and an enforcement plan for reducing solid waste, including recyclable materials and food scraps.”

- Required Dishwasher Language for Schools
  - Lexington updated their [INTEGRATED BUILDING DESIGN & CONSTRUCTION POLICY](#) to require the installation of dishwashers for reuse
    - Model Language:
      - Dishwashers installed for all eating areas - All kitchen/food preparation areas within buildings should be designed for and include dishwashers appropriate to the size of the intended population it serves. This would include cafeterias and break rooms (anywhere food would be prepared or stored). There should also be enough space to store, clean and collect used reusable foodware for eating areas as well as good design to dispose of extra liquids and to separate food waste from other trash.
- School Infrastructure Questionnaire

  - School of 500 can save \$7,000/yr
  - Dual stream milk dispenser - Gives 2 milk options as required
    - different fat levels, chocolate, plant based milk
    - \$3,500 per dispenser

      - Milk in blanket contract
  - Trays specific to carry milk
    - Milk goes in middle due to weight

      - Donate to local food bank

    - Small implementations first
    - Switching to bulk condiments/milk
    - Incorporating into composting programs with Green Teams and schools
    - Collecting data around trash/waste reduction and GHG emissions
    - Why food ware should not be considered dangerous
      - Books, scissors, cell phones and other items are not lumped into this same 'dangerous' category
      - Adults set the tone for how reusables are used and beneficial

    - Needham and Winchester are working with Re.Dish to sanitize reusable trays for schools
    - Having this wash hub can allow schools without dishwashing capacity and/or infrastructure issues to transition to reusables without need for labor or storage
    - Will the MA DEP Micro Grant be eligible to help with costs for start up service?
      - Likely yes, but need to confirm

  - Do schools follow State or Local health standards?
    - Same as a restaurant – Local health standards which can vary and be stricter than state health standards
  - Still looking into:
    - Who regulates food in school?
    - Can a fan be used to help dry trays?
    - Can trays be left to dry overnight?
