TOURNAMENT SPECIFIC INFO

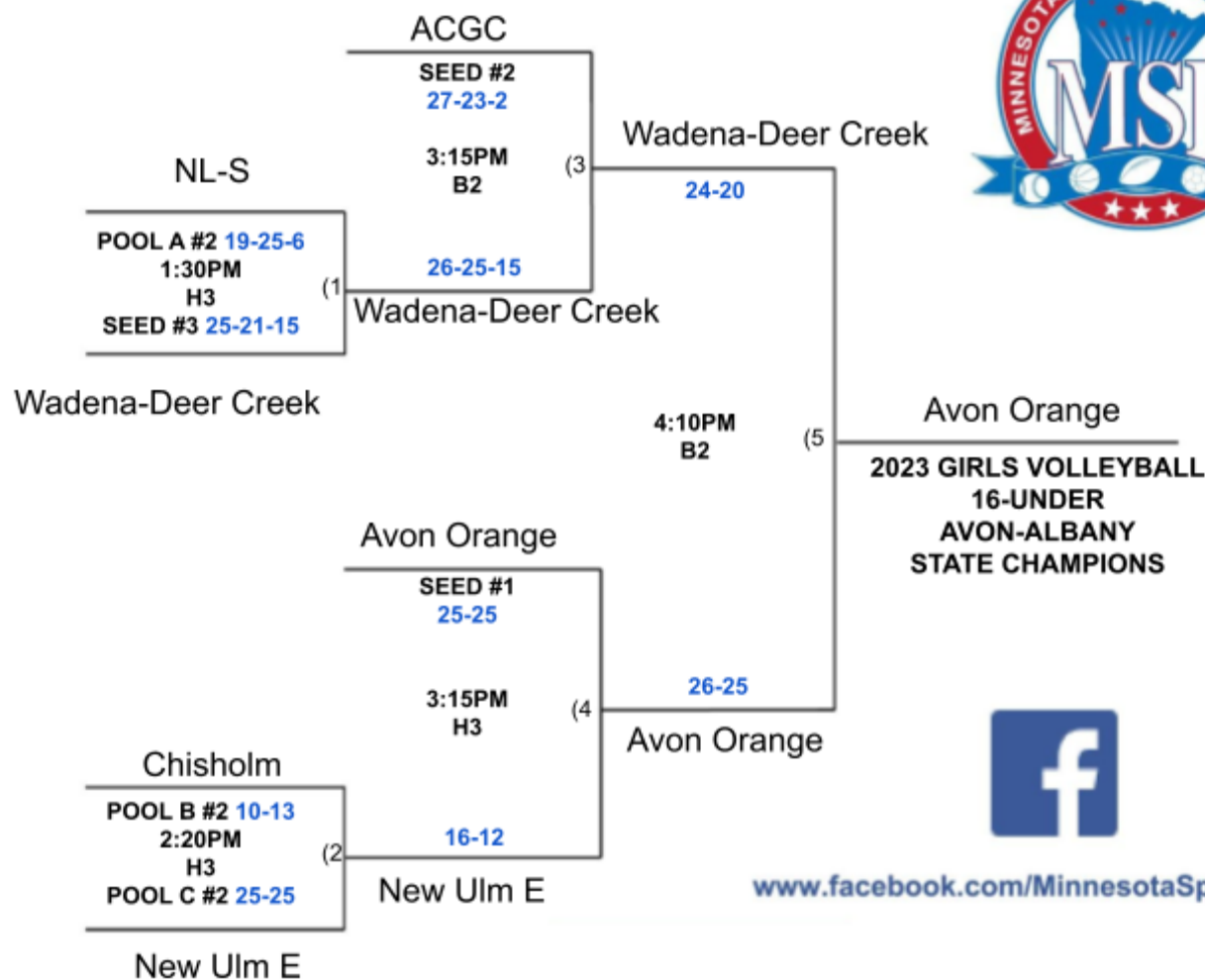
1. All pool play results count, unless there is a forfeit, in which case all results of the forfeiting team are canceled.
2. Pool play in three team pools is 3 games to 25 points each with 27 point cap. Pool play in four or five team pools is 2 games to 25 points with 27 point cap. Pool play in six or seven team pools is 2 games to 15 points each with 17 point cap.
3. Top two teams in pool play advance to Championship series with third and fourth place teams advancing to Consolation series. Fifth place and below teams do not advance.
