CLIENT or NANNY shall be responsible for compliance with all a p plica ble laws r elatin g to e m ployment of a NAN NY, including, but not limited to, p ayment of all a pplicable payroll taxes, Social Security, or Medicare assessments, and Federal or State withholding or unemployment taxes arising as a result of employment of any NANNY by CLIENT.
- c. NANNY agrees to keep all the information given to NANNY about the CLIENTs confidential.

INDEMNIFICATION

NAN NY s h all ind e m nify a n d hold t h e AGENCY, its m e m b e r s, managers, directors, officers, employees, successors, or assigns, harmless from and against any and all suits, actions, losses, damages, claims, or liability of any character, type, or description, including without limitation, all expenses of litigation, court costs, and attorney's fees, for injury or death to any person, or injury to any property, received or sustained by a ny p e r so n or p e r so n s or p ro p e r ty, alleg e d by t h e CLIENT, t h e NAN NY, the CLIENT's family or any third party, including acts of omission or co m mission on t h e p a r t of t h e N a n ny, CLIENT or CLIENT's fa mily, a n d

including claims and damages arising in whole or in part from the n e glige nc e of the AGENCY.

- b. NAN NY r ele a s e s a n d disc h a r g e s t h e AGENCY, its m e m b e r s, managers, directors, officers, employees, successors, and assigns from any and all payments, claims, demands, debts, accounts, judgments, grievances, actions, causes of action, contributions, indemnities, losses, damages, expenses, costs, professional fees (including, but not limited to, attorneys' fees) and liabilities of any kind, nature and description whatsoever, now accrued or which may hereafter accrue ("Claims") relating to or arising out of the performance or nonperformance of this.
- c. NANNY acknowledges and agrees that the foregoing release of Claims is intended to be a full and final settlement and release of all Claims that may arise from the performance or nonperformance of this Agre e m e n t b u t t h e AGENCY, includin g, b u t not limite d to, t h e Agency's referral services.

I certify that the answers and information given in the Nanny Application (submitted prior to this Agreement) are factual, true and completed to the best of my knowledge. I understand that falsifications, omissions, or misrepresentations may be cause for rejection of my application by the Agency and/or any of its Clients.

I authorize the investigation of all information contained in this application as is de e m e d n e c e s sary. I further authorize any e m ployer, person, corporation, educational institution, or any other entity listed within, including the Agency, to answer any and all questions regarding me and my information as it relates to Nanny services and agree to hold all persons harmless for providing any and all information within their knowledge or records.
