And re: Section 12 of the Public Guardian and Trustee Act, R.S.O. 1990, c. P.51(the "Act")

The undersigned, concerned artists, the Sudbury community, and national arts and museum professionals, request the intervention of the Public Guardian and Trustee to protect and administer certain property which is subject to a charitable or public trust (collectively, the "Trust Property").

Trust Property

The Trust Property is located in the City of Sudbury, in the Province of Ontario, and includes the following: (i) the Bell Mansion, (ii) the Laurentian University Museum and Art Centre Collection (the "LUMAC Art Collection"), (iii) the LU Museum and Art Centre Library, and (iv) the B.A. McDonald Funds. The Trust Property is described in greater detail in the Appendix to this letter.

Background:

AGS is a public art gallery and arts education centre that has served Sudbury and the North-Eastern Ontario Region since 1967. Laurentian University of Sudbury ("LU") is a publicly funded, bilingual and tri-cultural post secondary institution incorporated by Statute in 1960. LU commenced restructuring proceedings under the Companies' Creditors Arrangement Act ("CCAA") on February 1, 2021, with Ernst & Young acting as Court appointed Monitor. LU emerged from CCAA proceedings in November 2022.

LU acquired the Bell Mansion from the Sudbury Centennial Museum Society in 1967 for a consideration of one (\$1.00) dollar. At the time of the transfer, LU and the Chamber of Commerce entered into an agreement which states, inter alia, that "the [university] agrees to use of the aforesaid lands and premises when received for the purpose of a Museum and Arts Centre to be known as the Sudbury Centennial Museum and Fine Arts Centre of Laurentian University and use [sic] by the University to promote appreciation and enjoyment of the Arts by the public"

LU operated a public art gallery and arts education centre ("LUMAC") in the Bell Mansion from 1967 until 1996. In 1996 LU, under pressure from cuts in government funding, withdrew its support for LUMAC. This action by LU led to a groundswell of opposition by the Sudbury community and by artists who had donated works to LUMAC¹. LU, following discussions with the LUMAC Advisory Committee and community groups, made a proposal to keep the art gallery open, "contingent on strong community support"². "On August 12, 1996, LU's Board of Governors approved a resolution to transfer responsibility for the operation of LUMAC from LU to a community-based organization and to eventually transfer the assets (including the building and art collection) to the new corporation 'upon satisfactory evidence that the new entity is able to ensure the continuing operation of the facility'³.

Arrangements between LU and the AGS were formalized in a Memorandum of Agreement ("MOU") dated October 20, 1999⁴. By the terms of the MOU, LU retains AGS to manage and operate a gallery and arts centre, including the LUMAC Art Collection, at the Bell Mansion for a term of 5 years. The MOU gives AGS a right of possession of the Art Collection and other assets for the term, but does not transfer legal or beneficial ownership of the Trust Property to AGS⁵. The MOU was renewed in 2004. There do not appear to have been any further written renewals; however LU and AGS continued to operate under the terms of the MOU.

As mentioned AGS initially filed a proof of claim in the LU CCAA proceedings and then sought leave of the Court to withdraw its claim without prejudice to any future claims it might make asserting ownership of the Trust Property. AGS's motion was settled on terms annexed as Schedule 'A' to the Court's Endorsement dated June 17, 2022 (the "Settlement")⁶.

The Settlement provides, *inter alia*, that: LU would permit AGS to continue to operate as a public gallery and arts centre in the Bell Mansion until May 30, 2025 (the "Vacate Date"); LU would be free to sell the Bell Mansion after the Vacate Date; AGS acknowledges that it has no property interest in the LUMAC Art Collection and the B.A. McDonald Funds; LU agrees to comply with any restrictions to which the artwork is subject; and nothing in the Settlement is to be construed as an acknowledgment that LU owns the art.

The Settlement does nothing to alter any trusts or restrictions to which the Trust Property may be subject. It is clear from the documentation that AGS was retained by LU as custodian and operator of the Museum and Art Collection and does not have legal title to the Trust Property. It is equally evident that LU has legal title to these assets subject to charitable or public trusts.

While the CCAA proceedings may (or may not) shield LU's officers and Board of Governors from liability for claims arising from the university's mishandling of the B.A. McDonald Funds, it has not affected LU's fiduciary obligations in respect of the Trust Property.

Where matters stand today

The AGS closed the Bell Mansion to the public in October 2023 after LU identified structural problems in the building. The artworks (comprising both the LUMAC Art Collection and works belonging to AGS), the library and other furnishings remained in storage at the Bell Mansion until the end of May 2025. At that time, everything was moved into storage at LU and the Bell Mansion was vacated. We are informed that both packaging and environmental conditions are unsuitable for proper storage of the artworks. LU's Board of Governors approved the sale of the Bell Mansion in December 2024 and the university plans to list the property for sale before the end of July 2025⁷. There is community opposition to a sale, demanding that the building be maintained for public purposes⁸.

There is great concern both within the Sudbury community and among artists that LU will sell the artworks to help resolve its continuing financial problems⁹. We feel that in the legal proceedings that have taken place, AGS was concerned to assert its ownership of the Trust Property and LU and the Monitor were concerned to assure the restructuring of LU's debt, but no one represented the public interest in preserving the Trust Property as a public trust. We appeal to the Public Trustee to take such measures as you may consider necessary and appropriate to protect and maintain the Trust Property including:

- That a caution be placed on title to the Bell Mansion to ensure that any subsequent purchaser is subject to the restrictions on use set out in the 1967 agreement between LU and the Sudbury Chamber of Commerce.
- That, if the Bell Mansion is sold, any proceeds received by LU, are subject to a trust "to promote appreciation and enjoyment of the Arts by the public".
- That the LUMAC Art Collection and LUMAC library are preserved intact for the benefit of the public.
- That if LU is unable or unwilling to act as Trustee, or has failed in its obligations as
 Trustee of the Trust Property, a suitable successor be found and that the legal title to the
 Trust Property be transferred to that successor Trustee.
- That all reasonable measures are taken to ensure that the art collection, library, furnishings and records of the gallery (including both the LUMAC Art Collection and the AGS collection), are stored in a secure location under environmental conditions that will protect them from damage or deterioration.

APPENDIX

Description of Trust Property

- (i) Bell Mansion: The Bell Mansion was, until May 30, 2025, the home of the AGS public art museum and housed the AGS permanent collection and art library. Since 1967 and until the AGS was forced to suspend operations in 2023, the art collection and library have been on display for the benefit of the public. The Bell Mansion, known municipally as 251 John Street, was built in 1907 by local businessman and philanthropist William Joseph Bell. When Mrs. Bell died in 1954, she willed the mansion to the Memorial Hospital. The property was damaged by fire in 1955 and was used for several years by the Masons as a clubhouse. Between 1966 and 1969, the Sudbury Chamber of Commerce rebuilt the interior of the Bell Mansion, as a Centennial project, for the purpose of creating a Sudbury community museum and art centre. Title to the property was transferred to LU from the Sudbury Centennial Museum Society on December 5, 1967 for one (\$1.00) dollar. At the time of the transfer, LU entered into an agreement with the Sudbury Chamber of Commerce (referred to above) which states, inter alia, that the property will be used "for the purpose of a Museum and Arts Centre to be known as the Sudbury Centennial Museum and Fine Arts Centre of Laurentian University and use [sic] by the University to promote appreciation and enjoyment of the Arts by the public". The transfer was registered on title on November 14, 1969, and LU continues to be the registered owner on title to the property. The property was designated as a heritage site in 1984. It is our view that any future transfer of title to the property would be subject to the restriction on use made for the benefit of the public, as set out in the 1967 agreement. In a proof of claim filed on July 30, 2021 (and subsequently withdrawn), the AGS estimated the value of the Bell Mansion and surrounding land at \$1.3 million.
- (ii) LUMAC Art Collection: LU operated and maintained the Laurentian University Museum and Art Centre (LUMAC) from the time of its founding in 1967 until the university withdrew its support for LUMAC in 1996. The artworks comprising the LUMAC Art Collection represent a portion of the AGS's permanent collections. Of approximately 2300 artworks housed and displayed by AGS, the gallery identified approximately 1400 as possibly belonging to the LUMAC Collection, the remainder being donated to, or acquired by AGS for its own account (Affidavit of Demetra Christakos dated April 8, 2022). The LUMAC Art Collection is composed of artworks donated to, or purchased by, LUMAC from the date it was established in 1967 up until 1997, as well as artworks, if any, acquired with funds arising from the disposition of works forming part of the LUMAC Art Collection. AGS and LU are separate charities. AGS was registered with CRA as a charity on July 1, 1997. The balance of the AGS permanent collections consists of works donated to, or purchased by AGS after July 1997. AGS assumed responsibility for the care and administration of the LUMAC Art Collection under an agreement (the "MOU") made with LU in 1999. In the claim filed by AGS on July 30, 2021, they estimated the value of the LUMAC Art Collection at more than \$4.85 million.

There is an abundance of evidence that LU holds the LUMAC Art Collection in trust. The governing document of the Laurentian University Museum and Art Centre states:

"Position: Board of Governors, Laurentian University

- A. Area of Authority
- 1. The Public Trust:
 - (a) All trustees are private individuals who together with their fellow members of the Board are fiduciaries for the public and have the collections, property, premises and resources of their institution in their care as assets in trust for the public of the present day and descendants of that public in the future.
 - (b) The Board of Governors is publicly accountable for the security, documentation, long-term preservation and conservation of objects in the collection, for acquisitions and deaccessioning to professional standards, and for assuring their exhibition and interpretation to the public, and their availability, within the constraints of their security and preservation, for research and education.
- 2. Appointment of Advisory Committee

The Board of Governors shall appoint an Advisory Committee, representative of its publics, to counsel LUMAC's governing authority on its role as owner of museum collections and keeper of that trust.¹⁰

- (iii) LUMAC Library: The library collection consists of approximately 600 historical art books valued in the July 30, 2021 claim at \$20,000 (see also Affidavit of Demetra Christakos dated April 8, 2022).
- (iv) B.A. McDonald Funds: Particulars relating to the B.A. McDonald Funds are set out in paragraphs 19 to 22 of the Monitor's 11th Report dated April 13, 2022¹¹. We wish to note here that Barbara McDonald bequeathed two properties to LU subject to the proviso that any capital and income received from their sale is to be held in a special fund specifically designated for the following uses:
- i. The purchase of artifacts, or
- ii. To pay the "cost of renovations or extensions to the Museum presently controlled" by LU "now located in the John Street and Ramsay Road area"; and
- iii. If Laurentian ceases to "maintain such a Museum", LU must pay the balance of the special fund or deliver all assets to the Royal Ontario Museum¹².

The fund was valued in the July 30, 2021 claim at \$203,963.94, plus accrued and unpaid interest of \$13,767.57. According to the Monitor's Report, "LU did not segregate the B.A. McDonald Funds. These funds were deposited into LU's general operating bank account and utilized generally in operations."¹³
