Mrs. Castille presented the board with the budget versus actual report for the general funds. After a brief discussion, Mr. Baham made a motion to accept the report, with a second by Mrs. Sue Patrick. All were in favor; no objections. The motion passed.

Mrs. Decuir requested the board's approval for the 2025-2026 enrollment and lottery procedures. The document is requested yearly by the state and must be approved by the board. There are no changes to the policy. This year's open enrollment dates will be January 15 - February 15, 2026. Mr. Judice made a motion to accept the policy and procedure, with a second by Mrs. Perry. All were in favor; no objections. The motion passed.

Mrs. Decuir advised the board that she received written correspondence from our attorney on the matter Mrs. Shannon brought before the board regarding her retirement insurance premium rates. Mrs. Decuir read the letter and informed the board, as per legal counsel, it would be illegal for V. B. Glencoe Charter School to pay additional funds towards the retirement benefits of any employee.
