Welcome to the Sachem CSD! If you choose to homeschool your child for the 2024-2025 school year, please find below helpful information on the Homeschooling regulations, as well as the ways in which families can submit required documents.

The NYS Department of Education provides regulations for families and schools to support us through the Homeschooling process. The Letter of Intent (STEP 1) is the first required document that is requested by July 1 for the 2024-25 school year. However, *Letters of Intent are accepted at any time* throughout the year. This should be followed by the student's Individual Home Instruction Plan or IHIP (STEP 2). Throughout the school year, (STEPS 3-4) Quarterly Progress Reports and the End of Year Assessment are also required.

Once submitted, we will notify you via email that we have received your Letter of Intent, as well as confirmation of approved Individual Home Instruction Plan (IHIP).

For special education services, the parent must request services in writing to the Board of Education of the school district by June 1 preceding the school year for which the request for services is made. If a parent makes the request for the provision of related services, a CSE will ensure that the IESP is created, and the services are documented. Related services will be provided in the building where the student would have attended.
