Terms and Policies for Exhibitors

By registering for and/or attending the NOSS Conference, all exhibitors agree to be bound by, and comply with, these Terms and Policies. It is the exhibitor's responsibility to read and understand these Terms and Policies.

Participation and Behavior: Conference badges must be worn to all functions. Exhibitors are expected to conduct themselves professionally at all conference functions. Excessive use of obscene language, abusive behavior, or threatening behavior directed to any other conference participant or staff will not be tolerated. NOSS has sole discretion, without refund, to refuse admittance to or expel from the conference anyone that is deemed to be behaving in a manner that could be disruptive to the conference or any other participant.

Insurance: Exhibitors are responsible for taking appropriate insurance coverage in connection with their attendance at the conference. Where the exhibitor is traveling from outside of their home country to attend the conference, appropriate travel insurance should be purchased independently and in advance of any travel or travel bookings.

In-Conjunction-With (ICW) Events: NOSS welcomes ICW events and appreciates the opportunities these events provide for conference participants. By registering as an exhibitor, you agree <u>not to hold ICW events</u> during conference hours. This includes ICW events during conference hours at locations other than the conference hotel.

Release of Liability: NOSS will use all due care for the provision of its services and activities provided to exhibitors. Attendees and guests participate in activities and use services at NOSS conferences at their own risk. No liability or responsibility is accepted by the NOSS for any injury, illness, damage, loss, accident, expense, or any other claim arising from involvement in any activities or provision of any services howsoever suffered.

Personal Property: NOSS accepts no responsibility for loss or damage to personal property.

Video Recording: Professional video recording of any type will be scheduled and provided by NOSS as the Conference Committee and Executive Board direct. NOSS reserves the right to use images taken at the conference with your photograph and/or likeness in future marketing materials.

Soliciting at the Conference: We encourage attendees to support the paid sponsors and exhibitors who, in turn, are supporting the industry. Soliciting by unregistered companies is prohibited at all NOSS Conferences. NOSS reserves the right to escort any individual from the conference if they are reported to be soliciting in the Exhibitor Hall and are not a conference sponsor or exhibitor. We also encourage attendees not to listen to a sales pitch from a non-sponsor or exhibitor.
