To ensure that the resources cited in a research paper can be found by readers, it is important to include a reference list that follows the APA Style 6th or 7th. The reference list should contain at least 10 primary references from journal articles over the last 10 years, and the numbers should be sequential as they appear in the text. Each reference list entry should have four elements: the author, date, title, and source, and should be alphabetically listed by author or title if there is no author.
