Superintendent Report

Dollars for Scholars Presentation

Dr. Syverson introduced Alumni Committee Joanna Kennedy (Tri-West Class of 1992) who presented the requirements of how students need to qualify for the scholarship, the length of the scholarships and the dollar amount the scholarships given, and the total amounts awarded to students over the last eight years. Increase of School Lunch Prices

Mr. Hobaugh stated we have not raised prices since prior to COVID. The required price from USDA and IDOE is \$3.25. Our average is \$2.80 (\$2.70 for elementary school and \$2.90 for middle school and high school meals) The USDA and IDOE can force you to raise the price required \$.45 but at this time still caps the max raise at \$.10. We are requesting to raise the price for all items by the \$.10 required.

Jami Thompson made the motion to approve the Increase of School Lunch Prices. JD Love seconded the motion and the vote was unanimous, 4-0.

TAG Policy

Mr. Hobaugh stated the requirement per IDOE to be eligible for the Tag distribution is to review and approve the TAG Policy. There are no changes from last year. Just meeting the requirements.

JD Love made the motion to approve the TAG Policy. Jami Thompson seconded the motion and the vote was unanimous, 4-0.

Bid Approval for PES Project

Dr. Syverson stated that the approval letters for the bids from Tecton were provided in the board packet for board approval. Bids came in over \$100,000 lower than projected which will allow for any unseen costs as we go through the upgrade process.

Jami Thompson made the motion to approve the Bid Approval for PES Project. Brad Williams seconded the motion and the vote was unanimous, 4-0.
