

KAIJU'S TERMS OF SERVICE AND TERMS OF PAYMENT

By purchasing a commission from me, you agree that you have read and agreed to everything written within this document.

TERMS OF SERVICE

"You", "your" and "yours" refers to the customer in all cases. "I", "me" and "myself" refers to the artist in all cases.

- You must be 18 or older to be able to buy a commission from me.
 - If it becomes apparent that you or any of those involved in the purchase of the commission are under the age of 18, you and the offending parties **will** be banned from commissioning me indefinitely.
- By commissioning me, you agree that you have read the terms of service.
 - If it becomes apparent that you have not read the terms of service, I reserve the right to refuse to work with you indefinitely.
- I reserve the right to decline a commission for any reason whatsoever, without any explanation.
- I reserve the right to change my terms of service without prior notice.
- I reserve the right to change my prices without prior notice.
- **All commissions will only be accepted through email unless stated otherwise.**
 - When sending a commission, please send your commission idea along with any reference important to the commission, such as a reference sheet and images of props you want included.
 - I will send an email reply informing you that your commission has been accepted or declined.
 - If your commission is accepted, I will ask you for more details about the commission. This will include specifics about certain details
 - If you do not respond to the above mentioned email in a timely manner of 3 days, your commission will be forfeited and someone else will replace your spot in my queue. Please inform me if you will take longer to respond.

- My turnaround time can take up to a maximum of 1 month from the start of the commission. I will always be transparent about the state of your commission, along with any possible delays.
 - You may contact me for updates at any time, but please be respectful.
- I will send you a thumbnail sketch before asking for payment. This will be used to judge the price of the commission I will be accepting. Please note that the thumbnail is not representative of the final image; it is just to show exactly what details will be included and what you will be paying for.
- Before inking and colouring the commission, I will send you a sketch for your approval.
 - You may ask for multiple revisions if you are unhappy with the sketch, up to a maximum of 5 revisions. Please be clear about what you want revised in each revision so as to make the process as smooth as possible.
 - Further revisions are liable to incur an extra fee depending on the scale of the further changes. I am lenient, however. If the change is miniscule, then I might not charge at all.
- If you decide to add more details than what was originally agreed upon, I reserve the right to charge you a fee before continuing work on the commission.
- Once the commission is completed, I will send the finished product to you for confirmation. You are free to ask for minor changes, such as certain colours and clothing details, or details that were missed that were clearly stated in the commission's description. You will not be charged for these changes.
 - Major alterations to the commission that were not agreed upon initially at this stage will have an extra fee added, or will be outright refused.
- If it has been agreed upon that the commission is completed, I will not make any more changes to the product. However, if you require an important change, I might be able to make an exception.
 - Important changes include, but are not limited to:
 - The character's gender has changed and the finished commission causes discomfort to you.
 - A significant error went unnoticed.
- Please note that my style can change between commissions as I am prone to experiment. If you do not get what you wanted, please make sure to notify me in the sketch phase of your commission.
- Unless agreed upon beforehand, you may not use my art for commercial use. You are not allowed to use my art with any form of artificial intelligence technology. This includes:
 - Reproducing and selling my artwork.
 - Using the artwork either directly or indirectly for any form of profit, including cryptocurrencies and NFTs.
 - Claiming complete ownership of the art in any way, shape, or form.

- Using my artwork to train AI image generators.
- If you do wish to use my artwork for commercial use, the price will increase or I will ask for dues/royalties along with the initial price.
- If you wish to be referred to as “anonymous”, please notify me in the initial commission request or any time before I post the image online.
- If you wish to not have the commission posted at all, please inform me in your initial commission request or any time before I post the image online.

TERMS OF PAYMENT

- All prices listed are in USD.
- I only accept payment through PayPal.
- Before asking for payment, I will send you a thumbnail. A thumbnail is a small sketch drawn in a few minutes with the aim of showing the basic idea of what the finished drawing could look like. This includes the pose, the camera angle, and the positioning of props and other elements in the drawing. I may make more than one, and you are free to choose from the selection and ask for different ideas.
- After the thumbnail has been selected and approved, I will send you a PayPal invoice with the amount due.
- I accept partial payments for previous and repeat customers should the commission become too expensive. Please discuss this beforehand so that we may discuss the time period and amount paid over time.
- I do not accept partial payments from new customers.
- The payment must come from your account, unless I have received clear permission from the paying party to use their account for the payment.

REFUND POLICY

- If I am, for any reason, unable to complete the commission, you are eligible for a full refund.
- Once the commission has been completed, you will not be eligible for a refund regardless of if you are happy with the commission or not.
