A SQR is submitted for the counts to be fixed. In the meantime, enter the counts that are in DRIVES as the most important part is the dollar amount matching.

Scenario: Cross County Credit Transfer

Customers may use prorated credit from their registration period if it did not expire before registering a new vehicle. Decided by the Project Guidance Request 3059, if the customer elects this option and the prior registration was in a different County, prorated credits for Specific Ownership Tax and registration fees (as applicable) can be pulled ("sourced") from the original County's revenue. Prorated credit transfers are paid from the source County to the destination County using revenue accounting entries (e.g. cash does not change hands). The portion of Specific Ownership Tax credited to the new County is redistributed during the new transaction. Money changes hands through adjustments in how much both Counties owe the State for the month in which the transfer occurred. One will pay more to the state (sends money), the other pays less to the state (receives money). The total amount kept by the state is zero.

The Daily Collections data cube is in the progress of being fixed. Some lien amounts are broken up into different fee amount that add up to the correct amount. This could happen if the clerk accepted a split payment. DRIVES prorates those payments based on fees in different line items. Please note that secondary offsets like county small balance adjustments are also classified as split payments from the perspective of the report.

Scenario: Lease Buyout Registration Card

When performing a lease buyout, the second lesse displays on the registration card even if they have been dropped from the activity. A SQR was submitted for this issue.
