Please provide further details on why you consider this option more appropriate:

I have been a local GP in the Mount Alexander Shire for the last 21 years and a recent member of YIMBY (Yes In My Backyard). I am passionate about the philosophy that Healthy communities promote healthy people supporting a healthier environment, and you can not have one without the other in the triad. My family and I have just built a new home on a block in town. Our compostnig system was the last thing to consider. I got my son to build the composting bays when I kept meeting our local neighbours visiting my next door neighbours composting bays with buckets of food organics to deposit. I asked my neighbour if I could deposit our compost... I was then introduced to the wonders of YIMBY. YIMBY is locally lead, locally run and is the most amazing social network system I have experienced in our community. I am heavily involved in

our local health system and involved in a number of local health-promoting activities such as our parkrun, Get-Connected Social Prescribing and local dance studio. YIMBY facilitate a community composting system based on expert practice, utilising and teaching the complex science around proper composting. They run education workshops and have a growing population of volunteers who move around the growing hubs to ensure a flourishing community of composters. YIMBY has been celebrated on national TV and local and state members of parliament have been inspired by what is going on here. My heart sank when I received this email explaining the state government is proposing the FOGO service. I understand the science is right, the intention is there, but yet again here comes another example of the government coming in to centrailse a process already thriving in a community - how very colonial of us?! The proposal takes out the community and individual engagement in the process and the very key to its success. FOGO services are all about the compost where as YIMBY is so much more. Healthy management of organics is the by product, the social connection and community engagement for individuals is what will make for greater impacts on our people and our environment. Government run programs through my experience in health care generally miss the mark, get tied down in red tape and generally fall over with the next election cycle and change of government. Let the people that matter run it and let it thrive. To this end the option to delay the FOGO services to 2030 would allow more research and support to be focussed on community-based programs like YIMBY. Support these programs to upscale and thrive. Introducing similar programs will only dilute their resources, thus diluting their effects and success.

### Please explain your answer:

The state based FOGO system from my understanding is merely providing one single bin for both food and garden organics. The aim of making it simple for householders to dump their food scraps and garden waste, is simplifying the science to the detriment of the process. Community-based programs like YIMBY mean we get the proportions right from the start, householders get educated about the process and

may even benefit from keeping the resulting high quality compost local - in our own backyards. I think this community engagement would also lead to individuals even looking at what is going out and what is going into their own bodies to even benefit healthier eating, producing their own food with building benefits for all. It is like the cliche, don't go into a village with a crate full of fish to solve the problem...teach the people to fish!

#### Please explain your answer:

Any model would benefit from kerbside pick up of organics to make it easier for householders to be involved. The highlight of YIMBY for me is local volunteers picking up householder buckets street by street. This busy social network has become a connection point for many, even acting as a welfare check point - if the bucket isn't at the gate then the community respond by checking in. Our little corner of the street has a WhatsAPP group, connecting the neighbours around our compost, but there are so many benefits. This is how the human species was meant to thrive. So our local community has a kerbside process. For state based process this would mean another coloured bin that people will just thoughtlessly dump all organics in, meaning another truck collecting service utilising resources that a community may not need as they may already have a environmentally clean process in place.
