Helpful Hint: I always give my students a deadline BEFORE my deadline.

Work Assignments:

Anyone registering an event for S&E will be required to complete a work assignment. Typically at the fall festival, everyone works a full day assignment.

Rules Review:

- * Festival is open to 7th and 8th grade students that are enrolled in your school's band or orchestra.
- * 9th graders who attend a jr high school may participate in EITHER MS or HS S&E.
- * Fee is \$12 / person / event.
- * Middle School events must be a minimum 90 seconds long to receive a rating.
- * Events must provide an original score for the judge.
 - *NEW THIS YEAR: State has provided a form for students to get signed in the office for music that is printed from the internet. This form can be found at this link in the report, will be sent to participating directors, and will be available at the site.
- * No photocopying will be permitted at festival.
- * If a published event includes a piano accompaniment, the accompaniment must be played.

- * One person plays each part (except for chamber ensembles).
- * ALSO NEW THIS YEAR: We will be requesting that teachers fill out adjudicator evaluations prior to leaving the event. Very few teachers actually fill out the evaluations later, which means adjudicators do not receive feedback and makes it harder for our VP of Adjudication to select good judges.

- Please complete surveys in the Newsletter! From broadening repertoire choices for Festival to contributing to our Basic Music List Guide, your participation can help directors in our state.
- Michigan Department of Education Physical Education requirements that correlate with marching band. We know programs strive to justify this credit so we connected the MDE standards that can be completed in marching band. Document to be approved and released soon!
- Ouidelines and talking points for directors to discuss with school administration to foster a strong music program. We created two different documents based on school sizes and typical issues such as justifying a designated class for beginners, timelines to purchase new uniforms, and advice about budgets. Here are the qualifications for Member Emeritus: (3 out of 5)

- 1. Regular participation in the MSBOA festivals with his/her students and performing ensembles
- 2. Service as an officer at the district and/or state level of the MSBOA
- 3. Service as a MSBOA committee chair or member at the district and/or state level
- 4. Service as a host, clinician, or chairperson for the MSBOA related events (e.g., festivals, meetings, honor bands and orchestras, workshops, etc.)
- 5. Service as an adjudicator in the MSBOA festivals

APPLICATION PROCEDURE: A retired instrumental music teacher should be nominated by a "sponsor" - someone who has first-hand knowledge of the retired teacher's success in instrumental music education. The sponsor should provide an emeritus application form as found in the MSBOA Yearbook to the candidate, collect the application from the candidate, write a short endorsement of the candidate, and then submit the application to the district executive board for consideration. District boards may use the information contained on the application and the criteria as advanced above to evaluate a candidate's suitability for emeritus status. Once the board approves the application, the president should sign the document and send to the MSBOA state office for review by the honorary and emeritus activities chair and the executive director. Once everything is deemed in order, the honorary and emeritus activities chair will present the candidate's name to the MSBOA state executive board in November of each year for its approval.

Upon approval by the state executive board, lifetime membership in the MSBOA will be granted to candidates receiving emeritus status. An emeritus member of the MSBOA is not allowed to vote or to hold office in the association, regardless of his/her employment status in a member school.

Update from the State Office

- The MSBOA Yearbook was emailed to all school member directors and has been posted on the MSBOA website as of August 26, and includes the following changes (among others) brought forth by the membership:
 - S&E accompaniment requirements, where "Accompaniment may be live, or a
 pre-recorded accompaniment provided by the publisher, or digital intelligent
 accompaniment software, e.g., SmartMusic.
 - o A rubric for All-State Auditions
 - o A new adjudicator review procedure
 - All the changes to the yearbook were brought forth by members seeking to improve the MSBOA, and we welcome your participation in the continued development of our organization!
- Financial health of the MSBOA
 - Excluding 2020 and 2021(when adjusting for pandemic needs), MSBOA has spent more money than it has brought in every year since 2011, averaging a deficit of \$43,459.58 over that time span.
 - Interest earned in our investment account has been used to make up for these deficits.
 - Without that money earning interest, we would have lost a total of \$801,532.07 and would have had to raise fees to remain financially viable.
 - While the organization does have money in the bank, it's important that the membership understands that we use the earnings of that account to offset our operating deficits.
 Without it, we would have to significantly raise fees.
- Deadlines: If there is a problem with meeting a deadline contact the State Office. Nothing can be done after the deadline has passed.

REMEMBER:

If paying by credit card, you have until 11:59 p.m. to complete the registration process and submit the credit card payment. After which, there is no need for further action. If paying by check, you will need to mail the check and a copy of the generated invoice to the State Office. The envelope MUST be postmarked on or before the deadline. It is strongly suggested all registrations mailed should be sent via certified mail with a tracking number. If your registration is not received in time, your post office receipt with tracking number will serve as proof of your complete registration.

- Saturday, September 7—Music Ed. Workshop & Festival Improvement Committee will meet or have met (depending on the date of the District Meeting). The MMC Executive Board and Planning Committee meetings will or have taken place on Sunday, September 8.
- Deadline for school membership---September 20, after which there will be an increase of \$40

- October 1– Deadline for District Transfers, All-State Audition registrations, and applications for the Adjudicator Workshop (which will be a B&O workshop).
- Check the MSBOA website and/or your email for the following:
 - o All-State
 - Audition requirements were sent via email and posted on the web on September 3
 - Registration opened on September 3
