Section 1 > Introduction

The following is an official report from the **Audit and Accountability Committee** outlining the findings and conclusions made during the course of an inquiry, certified by **Audit Command**.

The subjects within this case are the user <u>burgerhunter2000</u> and his various alternate accounts. Despite the previous Foundation Exile of <u>burgerhunter2000</u>, <u>xXParxityxX</u>, and <u>KbrineplayzYT</u>, all confirmed alternate accounts of <u>burgerhunter2000</u>, they are able to rejoin the Foundation.

Despite their recent exile, evidence has been found of <u>burgerhunter2000</u> attempting to bribe Witness A, a member of the MTF command team, into letting him into MTF as a Field Cadet. The Audit and Accountability Committee was alerted to this from a ticket created by Witness A. The Committee was also alerted to <u>burgerhunter2000</u> attempting to purchase Discord and Roblox accounts from members of MTF for the purpose of creating "content" for their YouTube channel. The information was provided by Witness B through an AAC ticket.

Section 2 > Methodology

The Committee was alerted to these actions from two reports sent via our ticket system. The tickets showed screenshots of <u>burgerhunter2000</u> attempting to bribe Witness A for an MTF rank and him attempting to pay members of MTF for their Roblox and Discord accounts. The Committee began investigating shortly after. A day after the tickets were sent, <u>burgerhunter2000</u> and their alternate accounts were exiled from the Foundation, as per the punishment from CI-003. There was a long delay from when this investigation was completed to when the punishment was filed. This exile prevented the Committee from conducting a hearing with <u>burgerhunter2000</u>, as they were now ranked Class-D and no longer a member of the Foundation.

Despite the exile, the Committee has still deemed this investigation and report necessary, as they could rejoin the Foundation at any time. The Committee then assigned a panel to this Criminal Inquiry and compiled all evidence gained that was relevant to this investigation. All evidence was gained via tickets, reviewed by Audit Command, and compiled into this comprehensive document. No hearings were conducted.

Section 3 > Inquiry Findings

Witness A's Ticket

Witness A opened #ticket-1696 with the Committee on <u>07/21/2023</u>, where they reported <u>burgerhunter2000</u> attempting to bribe them for an MTF position in discord DM's.

This screenshot shows <u>burgerhunter2000</u> blatantly engaging in bribery, trying to gain an advantage over other MTF Tryoutees.

Witness B's ticket

Witness B opened #ticket-1702 with the Committee on <u>07/22/2023</u>, where they reported screenshots of <u>burgerhunter2000</u> DMing Witness C, an MTF member, asking to purchase their Discord and Roblox accounts in order to make content for their Youtube channel on the MTF team. Witness B also reported <u>burgerhunter2000</u> contacting Witness D, a Foundation executive, further attempting to bribe their way into a position within MTF and the **Anomaly Actors**.

The screenshots from Witness C show <u>burgerhunter2000's</u> disregard for the Roblox ToS through their account purchasing attempts. Furthermore, they are shown once again attempting to bypass the entry process for MTF. The screenshot from <u>Witness D</u> shows <u>burgerhunter2000</u> once again attempting to bypass the entry processes for departments via bribing their way into AA, offering real-world payment which violates Roblox's ToS.

Section 4 > Panel's Conclusions

Executive Summary

The Committee has found sufficient evidence of <u>burgerhunter2000</u> attempting to bribe MTF Command and Foundation executives in order to bypass the selection process for MTF and AA. Furthermore, the Committee has found <u>burgerhunter2000</u> attempting to purchase accounts of MTF members using real-world money, once again attempting to bypass MTF's selection process and violating the Roblox ToS. The evidence gathered has been deemed sufficient, which leads to our Prosecutorial Recommendation.

Prosecutorial Recommendation

Upon consultation of the assigned audit panel, the Audit and Accountability Committee has decided upon the following suggested reprimands:
