Executive Order 1

Whereas it is the duty of the Governor of a state to ensure that the people of the state have their rights protected;

Whereas the right to keep and bear arms is an absolute right -- granted to we the people of the United States by our sovereign creator and codified in the U.S. Constitution -- that shall not be infringed;

Whereas Dixie, and every other state in the Union, is bound to uphold and protect the integrity of the Constitution from aggressors, foreign and domestic, and to fight against infractions of the Constitution through whatever means necessary;

Whereas there have been attempts to force the state, against the will of the constitutions delicately defined balance of powers, by the federal government, which has overstepped the limited scope of power reaffirmed in the 10th amendment to uphold unconstitutional restrictions on citizens natural rights and liberties;

Whereas while the Federal government has supremacy in the powers expressly delegated to it, it does not hold the supreme power to unilaterally infringe upon Second Amendment rights via regulating the sale, transfer, possession, arming, or manufacture of firearms, the raising, arming, and disciplining of the militia, or otherwise restricting or infringing upon the right to obtain, keep, and use firearms, firearm accessories, or ammunition;

Whereas the right to a fair trial with jury and judge independent from both parties is central to the Constitution and previous documents on human rights, such as the Magna Carta, from which all Anglo-Saxon legal heritage is derived. When the government acts as the final judge regarding the extent of its powers, usurping those enumerated, then it has committed an act of tyranny, transgressing human rights for the sake of authoritative force. Similarly, we believe that Federal weapon regulations have resulted in the Federal government acting as the judge, jury,

and executioner. We reject the notion that we, the states, should submit to the Federal government and aid them in enforcing their despicable acts;

Whereas the people of America have enumerated to Congress the ability to regulate interstate commerce and lay taxes on imports and excises, however, we reject the notion that these are so all-encompassing to regulate our essential human rights, ones that are necessary for the preservation of life, liberty, and property. These are meant to allow Congress to responsibly maintain the delicate balance of power between the levels of governmental administration. We reject the notion that Congress may abuse these powers to coerce firearms dealers and owners to obey their tyrannical laws or pay taxes to use their firearms, thereby obstructing their Second Amendment right;

Therefore, I, MrWhiteyIsAwesome, Governor of the State of Dixie, by virtue of the power invested in me by the Constitution of the State of Dixie, do hereby issue the following Executive Order, to take immediate effect:

SECTION I: MAKING DIXIE GREAT AGAIN

1. Any and all Acts, laws, court orders, executive orders, treaties, administrative orders, memorandums, rules, and regulations, regardless of enactment date, which infringe upon the right to keep and bear arms shall not be enforced in the State of Dixie, which include, but are not limited to:
 - a. Any tax, levy, fee, or stamp imposed on firearms, firearm accessories, or ammunition not common to all other goods and services which might reasonably be expected to create a chilling effect on the purchase or ownership of those items by law-abiding citizens;
 - b. Any registering or tracking of firearms, firearm accessories, or ammunition which might reasonably be expected to create a chilling effect on the purchase or ownership of those items by law-abiding citizens;
 - c. Any registering or tracking of the owners of firearms, firearm accessories, or ammunition which might reasonably be expected to create a chilling effect on the purchase or ownership of those items by law-abiding citizens;
 - d. Any act forbidding the possession, ownership, or use or transfer of a firearm, firearm accessory, or ammunition by law-abiding citizens; and
 - e. Any act ordering the confiscation of firearms, firearm accessories, or ammunition from law-abiding citizens.
2. The state of Dixie explicitly disavows, and refuses to recognize the aforementioned orders.

3. No person, including any public officer or employee of this state or political subdivision of this state, as well as those receiving direct government contracts or subsidization from the state of Dixie shall have the authority to enforce the Federal Acts, laws, court orders, executive orders, treaties, administrative orders, memorandums, rules, and regulations mentioned in clauses 1 of this Executive Order.

SECTION II: ENFORCEMENT

1. Any person while acting as an official, agent, employee, or deputy of the government of the United States, or while otherwise acting under the color of federal law while within the borders of this state, who knowingly:
 - a. Enforces or attempts to enforce any of the infringements identified in Section I of this Executive Order; or
 - b. Gives material aid and support to the efforts of others who enforce or attempt to enforce any of the infringements identified in Section I of this Executive Order;

shall be:

- a. permanently ineligible to serve as a law enforcement officer or to supervise law enforcement officers for the state or any political subdivision of the state and,
- b. indicted and charged by the Attorney general for communism under the law of the state of Dixie.
