Dear Governor Newsom,

We, the undersigned organizations, respectfully request you immediately grant pardons to two long-time California residents: Judy Van Arsdale and Emily Warnecke. Both Judy and Emily were adopted from Asia as children by U.S. citizen parents and discovered as adults that their citizenship had not been secured. Pardons will allow Judy and Emily to restore their immigration statuses, access critical benefits, age with dignity, and live without fear of being separated from their families and the only country they know as home. Judy, Emily, and all intercountry adoptees adopted by U.S. citizens should be granted U.S. citizenship immediately. Denial of U.S. citizenship and deportation of intercountry adoptees are violations of their civil and human rights.

## **Background**

Judy Van Arsdale and Emily Warnecke were both adopted as children by U.S. citizens and U.S. military veterans and brought to the United States to be integral members of their families. Their adoptive parents assumed that their adoptions secured their U.S. citizenship, but unfortunately this was not the case. As a result, both Judy and Emily, both aging senior citizens, are being denied critical benefits such as social security and disability benefits, and are struggling with poverty and housing insecurity. To make matters worse, even though they have lived in the United States for close to 50 years, they wake up every morning in fear of being detained and deported to countries where they cannot speak the language, do not know the culture, and would face even worse social and economic difficulties.

Born in Taiwan, **Judy** was the oldest of eight children of a single mother. When she was 12, she needed an emergency surgery. As part of the negotiations to cover the medical costs, Judy was adopted by her surgeon, a missionary and former U.S. Army doctor, stationed with his wife in Taiwan. They brought Judy to the United States, where she was severely abused by her adoptive mother. Judy left home as soon as she turned 18, and struggled to survive. Due to her previous interactions with the criminal legal system, and despite having fulfilled all requirements from the courts, Judy cannot restore her immigration status. She is now 65 years old, has lived in California since 1978, and cannot access social security and government services she needs to live a stable and safe life.









**Emily** was adopted from South Korea by a World War II veteran and his wife and brought to California in 1964 when she was three months old. Her adoptive parents believed Emily automatically became a U.S. citizen when they finalized her adoption. Marrying when she was just 17, Emily endured several years of domestic violence. Stemming from this terrible situation, Emily had interactions with the criminal legal system, at which time she learned she was not a U.S. citizen. Now 60 years old, Emily lives under ICE surveillance and has a degenerative spinal disease, limiting her ability to work. Since she is not a U.S. citizen, she is unable to receive the full disability benefits she needs to make ends meet and faces housing insecurity.

California is home for both of these women, who have paid their debt to the state of California and the broader American society for their past mistakes. They are active volunteers in their communities and have both received Certificates of Rehabilitation. Restoration of their immigration status is critical for them to live the remainder of their senior years with dignity and respect, and without the constant fear of deportation from the only country they have known as home. As such, Governor Newsom, we implore you to grant Judy Van Arsale and Emily Warnecke pardons as soon as possible.
