

# CHILD ABUSE PREVENTION POLICIES

The State Alliance of Michigan YMCAs

Michigan Youth and Government

To protect children participating in youth programs and events by providing our staff and volunteers with policies to guide their conduct. These policies will also give staff and volunteers the knowledge needed to carefully and safely interact with children in our programs.

### POLICY 1: PROHIBITING THE ABUSE OR MISTREATMENT OF YOUTH

The State Alliance of Michigan YMCAs will not tolerate the mistreatment or abuse of youth in its programs or at its events. Abuse includes, but is not limited to, the following types:

- Physical abuse Injury that is intentionally inflicted upon a youth.
- Sexual abuse Any contact of a sexual nature that occurs between a youth and an adult or between two youths. This includes any activity which is meant to arouse or gratify the sexual desires of the adult or the other youth.
- Emotional abuse Mental or emotional injury to a youth that results in an observable and material impairment in the youth's growth, development, or psychological functioning.
- Neglect Failure to provide for a youth's basic needs or the failure to protect a youth from harm.

Any mistreatment or abuse by a staff member or a volunteer will result in disciplinary action, up to and including termination of employment or volunteer service.



## POLICY 2: PROHIBITING THE ABUSE OR MISTREATMENT OF ONE YOUTH BY ANOTHER YOUTH

State Alliance of Michigan YMCAs is committed to providing all youth with a safe environment in its facilities and programs. State Alliance of Michigan YMCAs will not tolerate the mistreatment or abuse of one youth by another youth.

In addition, the YMCA will not tolerate any behavior that is classified under the definition of bullying, and to the extent that such actions are disruptive, we will take steps needed to eliminate such behavior up to and including termination from Y programming.

Bullying is aggressive behavior that is intentional, is repeated over time, and involves an imbalance of power or strength. Bullying can take on various forms, including:

- *Physical bullying* when one person engages in physical force against another person, such as by hitting, punching, pushing, kicking, pinching, or restraining another.
- *Verbal bullying* when someone uses their words to hurt another, such as by belittling or calling another hurtful names.
- Nonverbal or relational bullying when one person manipulates a relationship or desired relationship to harm another person. This includes social exclusion, friendship manipulation, or gossip. This type of bullying also includes intimidating another person by using gestures.
- Cyberbullying the intentional and overt act of aggression toward another person by way of any technological tool, such as email, instant messages, text messages, digital pictures or images, or website postings (including blogs). Cyberbullying can involve:
  - o Sending mean, vulgar, or threatening messages or images;
  - o Posting sensitive, private information about another person;
  - o Pretending to be someone else in order to make that person look bad; and
- Hazing an activity expected of someone joining or participating in a group that humiliates, degrades, abuses, or endangers that person regardless of that person's willingness to participate.
- Sexualized bullying when bullying involves behaviors that are sexual in nature.
   Examples of sexualized bullying behaviors include sexting, bullying that involves exposures of private body parts, and verbal bullying involving sexualized language or innuendos.

Anyone who sees an act of bullying, and who then encourages it, is engaging in bullying. This policy applies to all youth participating in events and programs, as well as staff and volunteers.



#### POLICY 3: ANNUAL REVIEW OF CHILD ABUSE PREVENTION POLICIES

The State Alliance of Michigan YMCAs will annually review all child abuse prevention policies for relevance and will modify or rescind as appropriate. All staff will be notified during the next available annual training session if there are changes.

# POLICY 4: DEFINING APPROPRIATE AND INAPPROPRIATE PHYSICAL CONTACT

The State Alliance of Michigan YMCAs physical contact policy promotes a positive, nurturing environment while protecting youth and staff. The YMCA encourages appropriate physical contact with youth and prohibits inappropriate displays of physical contact. Any inappropriate physical contact by staff towards youth in the organization's programs will result in disciplinary action, up to and including termination of employment.

Our organization's policies for appropriate and inappropriate physical interactions are:

# POLICY 5: DEFINING APPROPRIATE AND INAPPROPRIATE VERBAL INTERACTIONS

Staff and volunteers are prohibited from speaking to youth in a way that is, or could be construed by any observer, as harsh, coercive, threatening, intimidating, shaming, derogatory, demeaning, or humiliating.

Staff and volunteers must not initiate sexually oriented conversations with youth. Staff and volunteers are not permitted to discuss their own sexual activities with youth.

Our organization's policies for appropriate and inappropriate verbal interactions are:

## POLICY 6: MANAGING THE RISK WHEN ONE VOLUNTEER OR STAFF MEMBER IS ALONE WITH ONE YOUTH

To protect YMCA staff, volunteers and youth, staff/volunteers are not to be alone with a single child (unless approved) where he or she cannot be observed by others. In situations where one-on-one interactions are approved, such as tutoring and private coaching sessions, staff and volunteers should observe the following policies to manage the risk of abuse or false allegations of abuse:

#### Additional Guidelines for One-on-One Interactions

- When meeting one-on-one with a youth, always do so in a public place where you are in full view of others
- Avoid physical affection that can be misinterpreted. Limit affection to pats on the shoulder, high-fives, and handshakes
- If meeting in a room or office, leave the door open or move to an area that can be easily observed by others passing by
- Inform other staff and volunteers that you are alone with a youth and ask them to randomly drop in
- Document and immediately report any unusual incidents, including disclosures of abuse or maltreatment, behavior problems and how they were handled, injuries, or any interactions that might be misinterpreted
- Supervisors must keep a schedule of private tutoring and coaching sessions, which should include times, youth involved, and location of sessions.
- Staff/Volunteers must have supervisor approval for any tutoring or private coaching sessions.
- Tutoring and coaching sessions with our organization's youth may not occur outside of the organization.



## POLICY 7: MANAGING INTERACTIONS BETWEEN STAFF AND YOUTH OUTSIDE OF REGULARLY SCHEDULED PROGRAM ACTIVITIES

Many cases of organizational abuse occur off-site and outside of regularly scheduled activities. This contact outside of regularly scheduled activities may put staff, volunteers, and the State Alliance of Michigan YMCAs at increased risk.

The YMCA strongly recommends that staff and volunteers do not have outside contact with youth from the organization. However, if off-site contacts are unavoidable, our organization has determined that the following forms of outside contact are appropriate and inappropriate:

In addition, when outside contact is unavoidable, ensure that the following steps are followed:

- 1. Supervisors should identify for staff and volunteers what types of outside contact are appropriate and inappropriate.
- 2. Ensure that staff or volunteers have the parents' permission to engage in outside contact with the youth. Consider requiring the parents to sign a release-of-liability statement.
  - If an arrangement is made between a YMCA staff member and a program participant or member for unsanctioned childcare; the YMCA staff and the family requesting care must fill out the Unsanctioned Childcare Waiver and Hold Harmless Agreement and turn into the YMCA HR office. THIS POLICY IS DESIGNED FOR THE PROTECTION OF ALL INVOLVED – CHILDREN, STAFF MEMBERS, PARENTS, AND YMCA.
  - To request a waiver, please see a senior staff member or the HR department.



## POLICY 8: GOVERNING ELECTRONIC COMMUNICATION BETWEEN STAFF AND YOUTH

Any private electronic communication between staff and youth, including the use of social networking websites like - Facebook, Instagram, Snapchat, instant messaging, texting, etc. is prohibited.

All communication between staff and youth must be transparent. The following are examples of appropriate and inappropriate electronic communication.

In addition, provide this information to your participant's parents so that they know what is appropriate and inappropriate from your staff.

## **POLICY 9: ADDRESSING CELL PHONE USE DURING PROGRAM HOURS**

Use of personal electronic communication devices to contact (via voice, text, or pictures/video) organization members and/or program participants for personal and/ or inappropriate reasons shall be grounds for discipline up to and including termination of employment.



## POLICY 10: EVERY ALLEGATION OF ABUSE TAKEN SERIOUSLY AND THERE IS COOPERATION WITH AUTHORITIES

All reports of suspicious or inappropriate behavior with youth or allegations of abuse will be taken seriously. The YMCA will fully cooperate with authorities if allegations of abuse are made and investigated.

## **POLICY 11: MANDATORY REPORTING REQUIREMENTS**

Staff should be trained to be aware of and understand their legal and ethical obligation to recognize and report suspicions of mistreatment and abuse. Staff will:

- 1. Be familiar with the symptoms of child abuse and neglect, including physical, sexual, verbal, and emotional abuse;
- 2. Know and follow organization policies and procedures that protect youth against abuse;
- 3. Report suspected child abuse or neglect to the appropriate authorities as required by state-mandated reporter laws as soon as possible, in no event later than 24 hours; and
- 4. Follow up to ensure that appropriate action has been taken.

#### **POLICY 12: CRIMINAL BACKGROUND CHECKS**

Because we are a youth-serving organization and the safety of children is of the utmost importance, The State Alliance of Michigan YMCAs requires a criminal background check for all full-time, part-time, temporary employees, and volunteers upon hire, once a conditional offer of employment has been extended by the hiring manager, program manager or a representative of the Human Resources.

A criminal record will not automatically disqualify an applicant from employment, volunteering or an employee from continued employment with the State Alliance of Michigan YMCAs. A variety of factors, such as the nature of the conviction, the relevance of the crime to the position, and the time that has elapsed since the conviction, will be taken into consideration.

If an applicant attempts to withhold information or falsify information pertaining to previous convictions, the applicant will be disqualified from further employment consideration with the YMCA due to falsification of an application.

An offer of employment may be extended to an applicant prior to the completion of the criminal background check. However, the applicant's first day of work in the position cannot begin prior to the satisfactory completion of the criminal background check.



#### **POLICY 14: CHILD ABUSE PREVENTION TRAINING**

The State Alliance of Michigan YMCAs requires all employees and volunteers take certain child abuse awareness and prevention training prior to their first shift. The State Alliance of Michigan YMCAs may require additional child abuse prevention and reporting training of some or all staff from time to time. Refusal or failure to take such training shall lead to disciplinary action up to termination of employment.
