1. Information We Collect

1.1. Personal Information

1.2. Mood & Journal Entries

- Mood logs, tags, notes, and journal entries are stored locally on your device by default.
- If you enable cloud backup, this data may be encrypted and stored securely in the cloud.

1.3. Usage Data

- Non-identifiable usage statistics (e.g., number of logins, time spent in app) may be collected anonymously to improve app performance and features.

1.4. Crash Reports and Diagnostics

- Anonymous crash reports and performance metrics may be collected using industry-standard tools like Firebase Crashlytics.

2. How We Use Your Information

We use your data to:

- Provide core features such as mood tracking, journaling, and personalized insights.
- Generate emotional trend visualizations.
- Send reminders if enabled.

- Improve app reliability, security, and functionality.

3. Data Storage and Security

- **Local First:** Your emotional and journal data is stored locally on your device.
 - **Encrypted Backups:** If enabled, backups are encrypted and stored using secure third-party services.
 - **Data Retention:** Your data is retained as long as you use the app. You can delete it anytime through app settings or by uninstalling the app.
