

Kingdom of Serramwen Document of Official Alliance

“In Favor of a Javaian Integration with the Kingdom of Serramwen”



Date: 26 May 2022

By the decree of their Imperial Majesty King Eugene I, of the Kingdom of Serramwen, the signatories of this document shall enter formal integration. This entails the protection of mutual interest and cooperation between the two nations, the Sultsanate of Javaï and the Kingdom of Serramwen. May they forever collaborate in prosperity, and may the universe be in their favour.

The terms of this agreement are as follows and may be negotiated:

- §1. The “Sultanate of Javaï” shall hereafter be integrated into the Kingdom of Serramwen as a Colony State.
- §2. The “Sultanate of Javaï” shall hereafter adhere to, and honor all Serramwen laws, including the Constitution and any future laws passed by the Government of Serramwen.
- §3. The “Sultanate of Javaï” shall hereafter recognize the Kingdom of Serramwen as their parent state and Eugene I and his heirs as their Monarch.
- §4. All Citizens of ‘The “Sultsanate of Javaï” shall hereafter be integrated as dual Citizens of the Kingdom of Serramwen.
- §5. All Citizens of ‘The Kingdom of Serranwen shall hereafter be integrated as dual Citizens of the “Sultsanate of Javaï”
- §6. The Kingdom of Serramwen shall hereafter have de jure political authority and de facto political authority over the “Sultanate of Javaï”.
- §7. The monarch of Serramwen shall hold the title “King” within the “Sultsanate of Javaï” this title will be de facto higher than any other title created within the “Sultsanate of Javaï” the monarch shall also hold the right to administer the server of “ the “Sultsanate of Javaï” as he will act as the server owner with the President acting as Co-owner and will administer in conjunction with the President of Bushistan, and shall serve as the main head of staff within the server.
- §8 Any and all laws within the “Sultanate of Javaï” shall remain in effect and will not be affected due to this treaty, other than their Constitution and declaration of Independence, these documents will hereafter be nulled.
- §9 The head of state of the “Sultanate of Javaï” may request to leave the Kingdom of Serramwen at any time and when the Monarch of Serramwen signs this request the ““Sultanate of Javaï” will cease to be a Colony State of the Kingdom of Serramwen.
- §10 The “Sultanate of Javaï” shall retain the rights to govern themselves within the original jurisdiction of the “Sultanate of Javaï” including the authority to create laws, self-govern and other administrative authorities within their original jurisdictions as long as it does not conflict with Serramwen Royal Decrees, Serramwen laws or the Serramwen Constitution.

- §11 This treaty will be effective immediately after being signed by the Monarch of Serramwen and the Sultan of Javai.
