Project:

Nepal ranks fourth in the global climate risk index among the most vulnerable countries. Climate change is considered as a conflict multiplier. Specifically, in fragile country like Nepal it will play huge role in its stability. In addition, Nepal once again experience the political uncentraintly and sections society have continued shown discontent over the current political course. If the emerging fragility risks are not identified and addressed in the early stages, this will poses a risk of exacerbating of the conflict.

In addition, in last 20 years, Nepal witnessed high rates of internal and external migration. Internal migration has increasedthe numbers of people living in the disaster-prone areas and increased competition for the resources. The external migration is the result forhuge shifts in the local economies, where women are often the main economic actors. As such, climate change is a more dominant force in people's lives and women are often disproportionately impacted.

However, there is a limited research and understanding on how climate change is interacting with conflict drivers in Nepal where social divide is already acute. As a result, there is gap in designing and implementing climate change resilience and adaptation programming including applying the conflict sensitivity lens. The proposed research work is aiming to understand the interrelation

between climate change, governance, peace and conflict with focus on women's role in climate resilient programming thus to mitigate conflict risks and/or exacerbate existing conflict drivers.

Objectives of the Assignment

Objectives of the assignment is to provide advisory role to the international Alert Nepal on the issue **climate change**, **gender and fragility**. Advisor will support International Alert to facilitate to build a framework on the climate change, governance and fragility. Advisor will provide support to develop high quality knowledge products specifically, the two upcoming research and a documentary. The most important role of the Advisor is to, identify the major stakeholders working in climate change including government agencies, donors and civil societies, conduct the dissemination workshops, and one-on-one meetings to share the key messages of the ongoing research on the climate change, gender and fragility.

Duties and responsibilities

- 1. Design and conduct one day capacity building workshop at the International Alert on the issue of Nepal's climate change, governanance and fragility. Identify the resource persons for the workshop and facilitate theworkshop.
- 2. Identify the major stakeholders who are working on the climate change and conduct the one-on-one meeting to disseminate and advocate the key message and the work of International Alert.
- 3. Design and conduct two half day research dessemination workshops with the major stakeholders.
- 4. Provide advisory support to on goingtwo research qualitative and quantitative research and documentary making. Specifically revising research questions, and documentary script and provide the inputs from climate change lens.
- 5. A brief policy review paper on the climate change from fragility perspective.
- 6. Final observation report of the all the activities.
