Reserved area and Parking provided

A maximum of 2 runs per day may be entered for each dog at the Scout, Ranger, Elite, or Veteran level. One run each is allowed for Team Relay and/or Duo in addition to 2 runs at the other levels. Entries can be made at any level with no prerequisites (except for the Veteran class, where the dog must be 8 yrs or older). There are no move-ups, as there are no restrictions to enter at any level. (Ex: You may run your dog once in Ranger and once in Elite on the same day.)

Entry fees must accompany all entry forms to be valid. A returned check does not constitute a valid entry. A charge of \$50.00 will apply for returned checks.

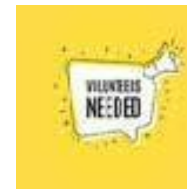
Notice:

All dogs must be on a short leash and under control while on trial grounds. Dogs **MUST** have a collar on during the run. Approved collars include any flat collar or harness (without tags). The collar/harness should be fitted and not dangling. No chains or e-collars are allowed. Covered prong collars are allowed. Dogs may run in a fitted vest, or coat - nothing can be dangling. Dogs **MUST** have a collar on during the run. NO flexi-leads allowed.
