The Employer now invites sealed tenders from Contractors for the following contract(s) to be funded by NEFCO costs:

Tenders for contracts financed by NEFCO are open to firms/individuals from any country.

When preparing the tender offer, the Tenderer should take into account that the works in this contract will tentatively start in *September 2023* and should be completed in *December 2023*

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- a) The average annual income for the last 3 years (2019-2021) is at least UAH 20,000,000. Documentation for 2022 is provided for reference;
- b) Experience of the contractor in 3 contracts during the last 5 years (2018-2022) with a total cost of at least UAH 20,000,000, which were fully and successfully completed and which are similar to the procurement in terms of the proposed equipment and works.
- c) In the event of a JVCA tender, the lead partner must demonstrate at least 50% compliance with requirements (a) and (b) above;
- d) Non-fulfillment of the contract by the Tenderer (including JVCA members, if applicable) has not occurred during the last three years (2020-2022);
- e) All pending legal proceedings against the participant (including members of the JVCA, if applicable) must not, in the aggregate, exceed 30% of the net asset value of the participant; The Employer reserves the right to cancel the tender in case of non-provision of credit financing for the project.
