

INDOMIDODOREX ART COMMISSION

TERMS OF SERVICE

Please read these terms before applying for a commission! You will be asked to confirm you've read and agree to these terms before your commission can be accepted.

1. GENERAL

- a. I can refuse a commission for any reason
- b. Client must be 18 years or older to commission me
- c. At this time I only work with US-based clients
- d. Please do not resell any of my work for more than you paid. You may include its total value in any sales.

2. PAYMENT

- a. Payment is accepted via paypal only.
- b. Client will be sent an invoice.
- c. The full amount is due up front. I do not offer payment plans on art commissions.

3. WAITLIST

- a. I work off a waitlist since the number of projects I accept payment for varies. Sometimes I may only take on one at a time or a few.
- b. The waitlist provides clients a way to secure a spot in my queue without paying until I'm ready to start work.
- c. When I'm ready for new work, I contact people on my waitlist in order.
- d. If you've changed your mind on the commissions you can back out at any time.
- e. If you repeatedly request to join my waitlist & back out over and over you may be temporarily blacklisted from joining the waitlist. Please make sure you're ready if you fill out my form!

4. PROCESS

- a. Once paid, a client's project is added to the end of my queue.
- b. Art commissions are worked on in order. I may occasionally work ahead a little while waiting for a client to respond.
- c. Clients are given an initial WIP sketch for approval.
- d. From there, WIPs are presented at various stages.
- e. When the work is complete, the client is presented with it for a final approval.
- f. Once the final is approved it is considered complete & is emailed to the client

5. CANCELLATION

- a. If the commission is not started the client can cancel for a full refund at any time.
- b. No refunds can be issued once the commission is started.

- c. If I decide to cancel your commission, even if it's been started, client will receive a full refund.
- d. There are no refunds, returns, or exchanges on completed commissions or purchases like adoptable sales.

6. USE RIGHTS

- a. Clients may repost my finished work anywhere with credit
- b. Clients may crop & resize work they bought to fit as banners, icons, etc..
- c. Clients may add text & use my work as a fursuit badge.
- d. Clients may use my work to print/make individual and personal-only pieces of merch(such as a single back or print)
- e. Clients may not use my work for any form of profit such as selling prints, pins, merch, digital downloads, etc..
- f. Clients may not edit, trace, or heavily copy my work.

7. CHARACTER RIGHTS

- a. Once purchased, the design and full character rights belong to the client.
- b. Client must credit me for the design.
- c. Client may make MINOR changes/adjustments to the design from the original.
- d. Clients may sell the design as a pre-made fursuit, use it in merch designs, etc.. There is no commercial fee.

8. NSFW ART

- a. Please use proper filters when reposting my NSFW art!
- b. Please do not share my NSFW art with minors. Do not send it to anyone without their prior consent.
