

THEMATIC SEMINARS

The thematic seminars (named “*Approfondimento:....*”) were created following the deactivation of free choice courses. The University Central Offices authorised the creation of the seminars under these specific conditions:

1. They must have just a “positive” outcome (and not a grade), therefore they do not influence the grade point average (see how to calculate the [grade point average](#));
2. They cannot have a disciplinary scientific sector;

Also:

- The **seminars must be attended and the exam must be taken in the same year of the offer**;
 - The seminars must be chosen from those offered and attended in the same academic year where it's possible to present the study plan, including in it the free choice courses (see here the website page dedicated to [study plans](#)).
 - The seminars must be registered via the exam verbalisation service with a digital signature;
 - Check the program (scheda informativa...) to discover if there are restrictions to the access based on the course you attend. Check the specific rules in the codes list below.

GENERIC SEMINARS CODES

A thematic seminar has a *generic code* when it has this generic name: “*Approfondimento: Seminario Tematico di Architettura*”. This name is used to identify a thematic seminar with no specific code, usually because it was activated after the university's deadline (after the 30th of April of every year).

It is possible to attend the new seminar and get its CFU without waiting for the seminar's code for the following year: this can be done by putting the generic seminar code in one's study plan.



The study plan cannot include two courses with the same code. For example, two generic seminars of 6 CFU with the generic code “*B020765 Approfondimento: Seminario Tematico di Architettura*” cannot both be included in the study plan.

HOW TO INCLUDE THEMATIC SEMINARS IN THE STUDY PLAN

- Who has already attended the seminar has to include the thematic seminar's code in the study plan.
- Who haven't attended the seminar yet has to speak with the professor to know if the seminar will be activated in that specific academic year.

After that, the seminar's code (generic or specific) must be included in the study plan.

For **STUDENTS CLOSE TO GRADUATION**: you can only attend thematic seminars offered until your graduation year. If the seminar is offered in the academic year after graduation, it can't be attended nor included in your study plan. For example, if someone is graduating in the academic year of 2023/24, he cannot attend thematic seminars offered in the year 2024/25.
