## **Orange Community Players Code of Conduct, Photo Release, and Emergency Information for Cast, Crew, and Volunteers**

**Updated April 2026**

### **Section 1: Code of Conduct**

Orange Community Players, hereafter referred to as (OCP), is a community-based organization dedicated to providing quality non-professional live theater to Orange County and the surrounding area. Participation in the organization's programs is subject to the observance of the organization's rules and procedures.

All participants in OCP productions and events must read and sign the Code of Conduct. Participants will be asked to sign the OCP Code of Conduct annually. Any participant or staff member who violates this Code is subject to removal from the program. The OCP Code of Conduct may be revised at any time, at the discretion of the OCP Board.

#### ***The activities outlined below are strictly prohibited.***

- Any prohibited behavior between adults, Teen Minors, and Minors age 12 and under as described in the [OCP Minor's Policy](#).
- Abusive language towards a staff member, volunteer, patron or another participant.
- Verbal, physical, discriminatory or visual harassment of another participant, staff member, patron or volunteer.
- Actual or threatened violence toward any individual or group.
- Bullying or taking unfair advantage of any staff member, participant, patron or volunteer.

- Possession or use of alcoholic beverages or illegal drugs at any OCP function or reporting to the program while under the influence of drugs or alcohol. \*An OCP social event or fundraiser, serving alcoholic beverages to interested adults, over the age of 21 years, would be an approved exception.
- Bringing onto OCP property or to any OCP function location, dangerous or unauthorized materials such as explosives, firearms, weapons or other similar items.
- Stealing or unauthorized possession of property of OCP or any of its participants.
- Conduct endangering the life, safety, health or well-being of others.
- Failure to follow any OCP policy or procedure.
- Failing to cooperate with an adult supervisor/leader/mentor.
- No smoking or vaping is allowed inside rehearsal spaces or the performance venue.

***I have read and I understand the OCP's Code of Conduct. I agree to abide by the rules described above and understand that I may be removed as a participant if I violate any of these rules.***
