This is the song many were calling a "diss track" aimed at Timothy. I believe it was aimed at the women that consequently spoke up about Melanie AFTER Timothy's story. These aren't random women either. Gina Frey worked with Melanie since she was on The Voice. Refer to the 2013 interview linked above for details on how they met. Stella Rose is also the actress seen in multiple Melanie Martinez music videos as well as a clothing designer that designed outfits worn by Melanie in photoshoots, music videos, and live performances (refer to the link above for her works). Maddie Carina's friendship with Melanie was less professional so there isn't specific work examples to cite other than photos of them together and fans knowing they were associated (hence why someone asked Maddie about Melanie on twitter). Maddie has been a popular instagram makeup artist for some time now. Lastly, Chloe Tersigni was the artist who allegedly made fan art for Melanie until

Melanie reached out to her and they became friends. Chloe ultimately produced the artwork seen in Melanie's album. More on Chloe Tersigni:

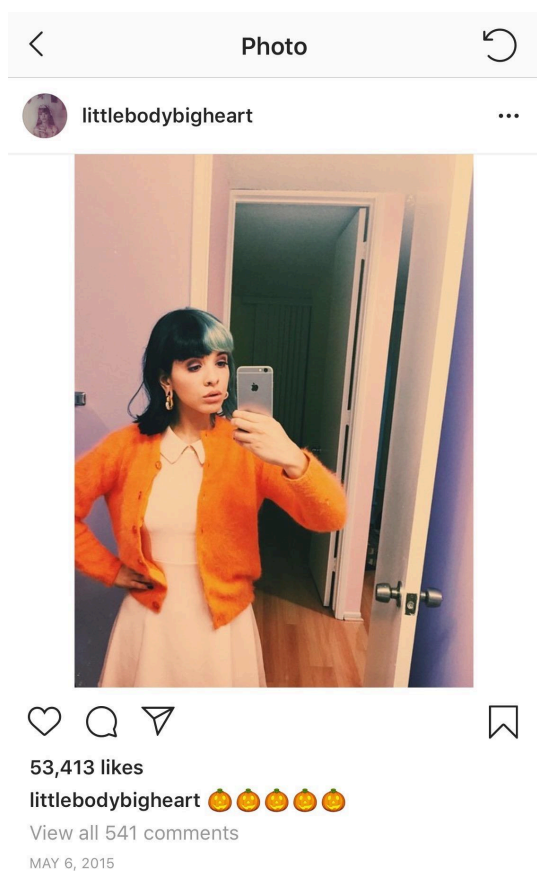

*Timothy said in a livestream that the reason she thought the date was June 25th was because she was wearing a wig on a picture from June 25th that she recalled wearing at some point during the night that it happened. I will look for the livestream as I did an oopsie and exed the tab. It seems to be more conclusive that the dates of the occurrence are actually on May 6th & 7th (or 5th?)
