- Call to Order and Approval of Agenda. President Dohrman led the discussion. Agenda was

- 3. Communications Andrea Little is connecting association members on farmer's market and parades, etc. for the summer. Rebecca Stickfort has banners and items to use for these events. Tara Pfantz discussed summer hockey registration. The Board decided \$250 for non AMHA skaters, and house and LTP skaters. Also discussion of voting status for annual meeting in April. Finally, it was mentioned that Rebekah Stickfort is resigning as Lead Manager, so that position will need to be filled.
- 4. February Financial Report. Nick Nelson led discussion. Nick did not have current exact financials to share but will email those out. Jana Brem is struggling to get everything in and taken care of for refunds. Jana has recommendation for next year on how to make that process smoother.
