What's the duration of a DWI record in NY?

DWI convictions in NY typically remain visible for 15 years from the date of conviction. DWAI convictions are shown for 10 years. Some severe offenses, such as vehicular homicide, can be displayed indefinitely.

What's the length of DWI probation in NY?

If convicted of DWI in NY, the probation duration could be 3 years for misdemeanor DWI and up to 5 years for felony DWI, along with other consequences.

How does NY deal with out-of-state DUIs for its residents?

NY may revoke the license of a resident convicted of an out-of-state DWI for at least 90 days. For drivers under 21, revocation can last at least a year.
