INFORMATION ITEMS

- White Activity Bus Use, Principals Dean Pilipchuk, Lara Jollymore and Miles Treiber, as well as Director of Transportation Kristen Disley joined the meeting to discuss white activity bus use at the schools.
 - There is a concern about the Board discontinuing the use of these buses in the smaller communities, where there are fewer alternatives to transportation. Is there a way to slow this process down so that schools can make a better informed decision. More clarification on the RFP and how it would affect the smaller remote schools would be appreciated before a final decision is made. They do not want to lose programming and opportunities to students due to the loss of affordable transportation. They currently have staff who are committed to obtaining the required training and providing the transportation for their students.
 - Paperwork is not coming in completed properly, and our transportation department is having to continually follow up with this. If we get audited and we don't have the proper paperwork, we will be fined heavily and possibly shut down.
 - We will proceed with the RFP for contracted transportation services so that we can make an informed decision. We will ask for Principals to gather feedback from parents and school councils on alternative ways to provide transportation and invite them to share their ideas with the Board. This information will be presented and reviewed at the June board meeting.
- Director of Student Services Kathy Murch and Student Services Coordinator, Leah Odynski gave an update on the previously proposed before and after school care program in Drayton Valley.
 - Advertised again in January for more registrations, and unfortunately we do not have enough to make this a viable program.
 - There will be further investigation to see if they can amalgamate the current registrations from Aurora and Evergreen into one Evergreen program, utilizing the current bus hub transportation, to make it viable.
- Director of Human Resources Dave Elwood introduced this year's Edwin Parr nominee, Lauren Bolton and her Principal from École Rocky Elementary School, Tim Bowman.

It is estimated that across the division, schools have connected with over 90% of the students, with between 70-90% of students actively engaged. A lot of the online tools have been made available for free, and schools are investing in hardware that improves student learning. Professional development is continuing across the division.
