RELEASE, WAIVER, INDEMINIFICATION, HOLD HARMLESS, AND ASSUMPTION OF THE RISK AGREEMENT

I, _____, in recognition of the fact that Recreational Shooting, Firearm Instruction, Self-Defense Training, the use of Loaned or Rented firearms, including but not limited to Pistols, Rifles & Shotguns, all have the potential to be inherently dangerous activities, and for and in consideration of Devine Arms, Instructor Alan Palomino, allowing me to participate in training, do hereby, for myself, heirs, executors, administrators, and assigns, release, indemnify, hold harmless and defend Devine Arms and their agents, certified instructors, servants, volunteers and employees from any and all liability claims accruing to me as a result of participation in training conducted by Devine Arms. This waiver is both personal and on behalf of any minor for whom it is executed. Persons under the age of 18 must have a parent or guardian present during class and sign this waiver. I also confirm and attest; that I am not a convicted felon, or under indictment in any court for a crime punishable by imprisonment exceeding one year, I am not a fugitive from justice, I do not use nor am I addicted to any unlawful controlled substances, I have not been adjudicated as a mental defective or have been committed to any mental institution, have not been discharged from the military under dishonorable conditions, am not subject to a court order restraining me from harassing, stalking, or threatening an intimate partner or child of the intimate partner, and have never been convicted of a misdemeanor crime of domestic violence. I also further attest to the fact I am not currently under the influence of any substances that may hinder or impede my actions in handling a firearm safely for the intended purposes of this course. I am a citizen of the United States, or lawful permanent resident, or I have been granted asylum by the United States. I also confirm and attest that I am not an illegal alien, have not renounced my United States citizenship, and am not prohibited from buying or possessing firearms in the United States. I understand that photographs and or video of myself and/or my property may be taken during the class and may be used for marketing purposes. If I am pregnant or breast feeding, I should consult with a doctor regarding the possible risks. The use of adequate eye and ear protection is my responsibility. I understand that during the course an instructor may need to touch me on the hand, wrist, elbow, arm, shoulder or back to position me to change my stance or grip. I furthermore hereby acknowledge and agree that I will always abide by all Devine Arms' rules, instructions, procedures, safety rules, and any and all Range Safety Officer instructions, whether communicated in writing, posted on the premises or communicated verbally.
