#### **MINUTES APPROVED FOR JUNE 6, 2023**

Dr. Connie Banks made motion to approve the minutes as presented. Ms. Connie Smith seconded the motion which passed unanimously.

#### **FINANCIAL REPORT FOR 2022-2023**

Mr. Andrew Dobson presented the financial audit for 2022-2023 on behalf of Halliday, Schwartz & Co. Mr. Dobson explained the financial statement and letter, and answered questions concerning the audit. A motion was made by Dr. Sarah Simmons to accept the audit as presented; Mr. Steve Skinner seconded the motion which passed unanimously.

# **DIRECTORS REPORT**

Mr. Greg Lovelace gave his Directors report which included Swofford program enrollment numbers and upcoming event dates for the 2023-2024 school year.

#### **CAPITAL NEEDS**

Mr. Greg Lovelace discussed potential capital improvement projects that need to be made to Swofford Career Center with the board and proposed a spending amount he felt would meet the schools needs and complete necessary projects. Ms. Connie Smith made a motion to allow Mr. Greg Lovelace to spend up to \$250,000 from the fund balance to make improvements deemed necessary. Dr. Sarah Simmons seconded the motion, which passed unanimously. Mr. Lovelace also discussed the need to hire an outside agency to present the board with possibilities on the school property for building expansion. Board members discussed the need for a new building to meet the needs of the growing communities and empowered Mr. Lovelace to pursue an outside agencies opinion.

## **SELECTION OF CHAIRPERSON**

Ms. Connie Smith nominated Dr. Connie Banks as the new Chairperson to represent Spartanburg School District Two, however Dr. Connie Banks turned down the nomination. Dr. Connie Banks then nominated Dr. Sarah Simmons for the position of Board Chairperson. Dr. Sarah Simmons accepted the nomination which was passed unanimously.

# **AWARD**

Dr. Mark Smith announced that Mr. Greg Lovelace had been nominated, and would be receiving the Richard M Couple Memorial Award for his service to the Employment Education class, and Special Education students at Swofford Career Center.
