	<p><i>All LEA users who will be working on the CGA in eGrants should plan to attend the training.</i></p> <p><i>The session will be recorded via screencast and a video file of the training will be posted in eGrants and Schoology within approximately 24 hours of the training.</i></p>
April 25, 2024	<p>LEAs can begin working on any section(s) of the CGA.</p> <p>CGA is open with <u>preliminary allocations</u> and <u>preliminary OEC rates</u>.</p> <p>Please remember that these budgets will have to be adjusted and “Zeroed Out” <u>once final allocations are loaded on July 8.</u></p>
July 8, 2024	<p>Final allocations loaded into eGrants</p> <p>Final OEC rates are loaded into eGrants</p>
July 15, 2024	<p>Voluntary/Early grant submission date (4:30 pm)</p> <p>Important Note - LEAs may choose to submit on this voluntary/early submission date for the purposes of recoding.</p> <p><u>LEAs are not required to make a submission on July 15.</u></p>
July 16–31, 2024	<p>Voluntary/Early review period for DDOE staff. LEAs that submitted on July 15 cannot make edits during this time period as the CGA is in “view only” status.</p>

August 1, 2023	Voluntary/Early applications returned for LEAs to revise
August 12, 2024	CGA submission date (4:30 pm) If an LEA submitted their CGA on July 15, a CGA re-submission is not required on August 12.
August 13–29, 2024	CGA review period for DDOE staff for LEAs that submitted on August 12. These LEAs cannot make edits as the application is in “view only” status.
August 30, 2024	Applications returned for LEAs to revise
September 16, 2024	<u>Required grant submission date - All LEAs are expected to make a submission no later than this date (4:30 pm).</u> <u>Submissions must include the completion of every area of the CGA that is applicable.</u>
September 17-29, 2024	Final LEA Submissions and CGA review period for DDOE Program Managers
October 4, 2024	Target date for DDOE staff to provide LEAs with final CGA approvals.

FY 2024-2025 Grant Cycle

Approximately 10-day turnaround on all **initial submissions**—which includes 8 days for Program Managers, Directors, and/or Associate Secretaries to review and 2 days for Consolidated Grant Coordinator to process.

Approximately 7-day turnaround on all **resubmissions**—which includes 5 days for Program Managers, Directors, and/or Associate Secretaries to review and 2 days for Consolidated Grant Coordinator to process.

Resubmissions can be made at any time.
