## 1. Introduction

This Privacy Policy describes what information we collect and how we use, disclose, transfer, and store it. If you do not want us to collect, store, use or share your information in the ways described in this Privacy Policy, you may not be able to play our games or use our services. Our commitment is to put users first. We strive to be transparent about how we collect and use information from our users, to keep the information we collect secure, and to provide users meaningful choices.

## 2. Information We Collect and How We Collect It

We collect various types of information about our users in connection with the Services, including; Information you provide to us; we collect the information that you provide to us, for example when you communicate with others or post, upload or store content, contact our Technical Support team, or provide billing information. Information we collect about your use of our Services; and including your IP Address, device model, browser version, operating system type, operating system version, mobile network information, device settings, and software data. Information we obtain from third-party sources (e.g. a social network such as Facebook) to share with us, such as your email address or other information that may identify you.

## 3. Information from Cookies and Other Technologies

We collect information using web beacons, cookies, and similar technologies. We may provide aggregated information, and data with personal identifiers removed, to third parties to describe how our customers are using the

#### **4. Security and Confidentiality of Your Personal Information**
