Definitions

For the purposes of this Privacy Policy: Account means a unique account created for You to access our Service or parts of our Service. Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Attendance app. Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Country refers to: Bangladesh

In Short: We collect your device information and location

Device information means, Device id(which is changable), device name, device model etc

Information collected through our App

We collect app functionality data which is inputed by user (Non personal data) like leave apply, ticketing for issue etc

How Do We Use Your Information?

We use your device information for fraud protection. We use this information to identify the user device uniquely and to make sure no other device can use the same account at the same time.

We use your location information for two purpose:

- 1. We collect your location data to make sure you are present at your workplace.*
